

Course: How to Manage Your Current Year Operating Budget

Course Description: This course will take you through managing the two components of your current year operating budget in the UAN software.

Component 1 Resources Available: We will begin with the initial certification of fund balances and revenue budgets and balancing your UAN software with the Amended Certificate. Also covered, when to request an Amended Certificate and how to add supplemental revenue budgets.

Component 2 Appropriations: Entering board-adopted appropriations in the UAN software, Temporary Appropriations and Permanent Appropriations. Also covered, how to enter board-adopted supplemental appropriations and reallocating appropriations inside and outside your legal level of control.

An internet browser window should open a registration webpage for the course you selected.

- **Step 2:** Enter your first name, last name, your email address, your job title, your organization (entity name), your county and your entity's four-digit UAN identification number.
- **Step 3:** Click the Register button. A confirmation email will be sent to your email address.
