

## A note from Auditor Yost on a UAN User Fee Reduction

To our UAN clients,

I am pleased to announce a five percent reduction in the monthly UAN user fee. This reduction is a direct result of the continued growth in the UAN clients. I am very excited about the sustained growth in the number of entities using UAN as their financial management system.

This reduction is in addition to the hardware surcharge holiday announced late last year that will be in place until Dec 31, 2014. It should be noted that the user fee reduction will not impact any past due amounts. So, for the very small percentage of clients that are past due please continue to work with us to address these issues.
