

#### **OVERVIEW**

This checklist is the recommended guide for closing the fiscal year for those who would like to follow a single path through the year end process. It is designed to be a concise step-by-step checklist to use *in conjunction with* the Year End Procedures booklet. Please refer to the Year End Procedures when greater detail on any particular step is needed.

**Please Note:** The Year End Procedures booklet will be available after installing the year end update disc: From the Windows desktop, click *UAN Tools*  $\rightarrow$  *Version Documentation*  $\rightarrow$  2025.1

When using this guide, you *must not* skip around; you must complete steps in the exact order presented. Skipping back and forth through this checklist may result in having to repeat the same steps multiple times.

Certain steps have been flagged with a \( \frac{\dagger}{2} \). The star icon signals that you can take immediate action to gather outside information, and prepare, or organize data before you have reached that step in the checklist. For details, read the year end procedures section referenced in each step with the star icon.

#### INSTALL

Install 2025.1 before beginning the year end process.

### **OPEN TEMPORARY MODE (ANYTIME AFTER DECEMBER 1)**

Open Temp Mode (General  $\rightarrow$  Maintenance  $\rightarrow$  Year End  $\rightarrow$  Open Temporary Mode)

- Year End Renaming form optionally revise Withholding Names.

  Renaming is **only** possible when opening Temporary Mode you **cannot** change existing withholding names **at any other time** during the year. When ready, save the form (with or without changes) and the application will process for 1-10 minutes. A message will open announcing UAN is in Temporary Mode. Click OK and UAN will close.
- Double-click the UAN icon and you will now have the option to login to the work year 2024 or 2025.

### STEPS TO CLOSE THE FISCAL YEAR 2024 (WHEN YOU ARE READY)

You must have 2024 closed before the calendar date of March 1, 2025. Otherwise, the application will lock you out of the work year 2025 until 2024 is closed.  $\Box$  Login to the work year 2024. ☐ Complete all 2024 Transactions. □ Verify Carryover Withholdings. For details, read Step 4H - Carryover Withholdings and Appendix 3 in the year end procedures. Print the Withholding Summary for 2024 (Payroll → Reports & Statements → Withholding Reports; make sure you do not change the report status from the default *Unpaid*). Confirm whether the list of withholdings should carry over to 2025 for payment. If a message opens that reads 'there is no data to report,' it means there are no remaining unpaid withholdings from wages posted in 2024. Note: when printing the unpaid withholding report as of 2024 it is proper for it to continue to list withholdings that were deducted from 2024 wages, but already paid to the withholding agencies in the work year 2025 (if any). □ Post any withholdings that are due for payment before closing the year (Payroll → Transactions → Withholdings Payments). Reminder: if the calendar date is already on or after January 1, you should post the warrant payments while logged into the work year 2025 i.e. you cannot backdate printed warrants. Clear any unpaid withholdings that you paid previously from Accounting instead of Payroll and/or that you should not carry over into 2025. (Payroll  $\rightarrow$  Utilities  $\rightarrow$  Unpaid Withholding Clear). Close (or Reduce) Purchase Orders. For details, read Step 4G - Carryover Purchase Orders in the year end procedures. Close purchase orders that should not be carried over into 2025 (Accounting → Utilities → Purchase Order Utility, using the Close Item button). Note: you cannot close purchase orders that you have already used in 2025 (i.e. carryover purchase orders), but you can reduce them. Reduce purchase orders that you intend to carry over to the amount needed after 2024 is closed (Accounting → Utilities → Purchase Order Utility, using the Adjust button). Verify W-2/W-3 and 1099/1096 form information. For details, read Appendix 2 & 3 in the year end procedures. Enter corrections before closing 2024. Edits to some of the following forms will not automatically update 2024 W-2 forms if done in the work year 2025 and more time-consuming manual edits will be necessary. □ Verify Employees' Name, Address, and Social Security Number (Payroll → Maintenance → Employees). □ Verify Local Tax W-2 Abbreviations and School District Numbers (Payroll → Maintenance → Withholdings). □ Verify Withholdings EFW2 Local Taxes locality information (only if applicable) for RITA or CCA electronic W-2 filing preparation (Payroll → Maintenance → Withholdings).  $\Box$  Verify the Federal and State Tax IDs and the entity address (General  $\rightarrow$  Maintenance  $\rightarrow$  Entity Setup, Entity Information tab).

	4G-Carryover Purchase Orders – verify the purchase orders that should carry over into 2025 (if any).
	Purchase orders carried over will reduce resources available for appropriation in 2025. Before closing
	the fiscal year 2024, close purchase orders that should not carry over and reduce purchase orders with
	remaining balances that are in excess of the amount you need to carry over for 2025 payments
	(whether posted or to be posted). Wait until you are about to close 2024 to mark the checkbox.
	4H-Carryover Withholdings – verify the total amount of withholdings that should carry
	over for payment in 2025 (if any). Carryover withholdings will reduce resources available
	for appropriation in 2025. If there are withholdings listed that were already paid (or will be paid)
	in the work year 2025, it is proper for the software to continue to report them as unpaid withholdings
	as of 2024. Wait until you are about to close 2024 to mark the acknowledgment checkbox.

> Confirm the Estimated Revenue column for each fund matches the total of the 'Taxes' and 'Other Sources' columns for each fund on the most recent 2025 Amended Certificate of Estimated Resources from the budget commission. Also, verify that the Total Estimated Resources on the report matches the Total Available for Appropriations on the most recent Amended Certificate of Estimated Resources.

Print Comparison of Budget and Appropriated (Accounting → Reports & Statements → Budgetary Reports). Confirm the Final Appropriation amount for each fund equals the fund subtotals on the appropriation legislation. The amount for each fund in the variance column should be a positive number or zero. It should not be negative (if it is negative, please review Appendix 4 in the year end procedures for further explanation).

Reminder: you are required to pass permanent appropriation legislation and input the amounts into UAN on or before April 1. After passing legislation, enter permanent appropriations under (Accounting > Maintenance → Appropriation Budgets, Add – Permanent Appropriation). Review the appropriation section of Appendix 4 of the year end procedures steps and reports for verification.
