IMPORTANT! – READ THIS FIRST!

UAN provides three guides for the year end closing process:

- 1. **Year End Checklist**: A form built into UAN that applies *minimum technical requirements* you must complete before closing the year with UAN.
- 2. **Year End Best Practices**. A concise guide to use in conjunction with the Year End Procedures. Recommended for those who would like to follow a single step-by-step path through the year end process.
- 3. **Year End Procedures**: A detailed guide to closing the fiscal year in UAN.

All UAN users should read the core instructions on pages 1-38.

Before beginning, it is essential to understand the organization of this booklet. We recommend first reviewing the Table of Contents to get the big picture before working through the details. The booklet is <u>not</u> in a standardized 'one-size-fits-all' chronological order as one might typically expect. Instead, due to the variety of circumstances in local governments and the flexibility of UAN, the order for completing the activities is adaptable to your particular entity. The instructions reference the appendices throughout, but the topics in each appendix may or may not be relevant to your entity.

In addition, we recommend reviewing our 'Housekeeping' videos if you have not done so previously. To view these, click the Accounting or Payroll link below (or enter into your web browser) and then scroll to the Housekeeping section:

UAN incorporates cross-reference links into the digital file of the Year End Procedures. Year End Frequently Asked Questions

FAQ #1	I understand that some year end reporting requires manual type-in or add-in documents created outside of UAN (e.g. Notes to the Annual Financial Statements, Hinkle System demographic and debt data, manually inputted reports, etc.). Question: When I send the year end audit submission by internet (or disc), is it necessary to include this data in the submission file or am I permitted to send it later?	
Answer:	All items applicable to the entity are required to be included in your final year end audit submission before the deadline set by the Auditor of State - financial penalties may be assessed for late filings. Please see the Important Note on page 24.	
FAQ #2	Can UAN transmit checkbook-level transactions to OhioCheckbook.gov for 2024?	
Answer:	Yes, but you must specifically authorize it for each fiscal year after you submit the Annual Financial Reporting file successfully to UAN. Please review page 38.	
FAQ #3	How do I print the Annual Financial Reports and December 31st YTD reports?	
Answer:	Refer to step '4C - Annual Financial Reports' in the Year End Procedures starting on page 14. Then refer to 'Appendix 2: Year End Reports' starting on page 44.	
FAQ #4	Where can I find the complete set of Version 2025.1 documentation?	
Answer:	After installing Version 2025.1, it will be available on your desktop in: UAN Tools → Version Documentation → 2025.1	
FAQ #5	Where can I get instructions and answers to questions about Temporary Mode?	
Answer:	Refer to Appendix 1: Temporary Mode, starting on page 40 and 'Step 3: Open Temporary Mode' starting on page 4 of the Year End Procedures.	
FAQ #6	Where can I find the Year End Balances Certificate in UAN?	
Answer:	Refer to 'Appendix 6: Year End Balances Certificates' in the Year End Procedures booklet starting on page 108.	
FAQ #7	Will I be able to print 2017 reports after closing the year 2024?	
Answer:	You will be unable to retrieve any 2017 reports from UAN after closing fiscal year 2024. If some reports are missing from your entity records, make sure to print and/or save them as PDF files before closing 2024. Refer to page 19 for details.

OPENING & USING THE YEAR END CHECKLIST

Entities using UAN are required to complete various procedures to close 2024 and advance to 2025. This booklet will guide you through those procedures. You complete the actual year-closing process via a "to-do list" incorporated into the application – the Year End Checklist.

UAN Menu General → Maintenance → >>Year End → Year End Checklist, then click 'Current Year'

IMPORTANT

The Year End Checklist form provides brief instructions on the MINIMUM technical requirements for closing the year in UAN, while this booklet includes details and important considerations.

All UAN users should read the core instructions of the booklet covered on pages 1-38. Some topics covered in the appendices may or may not apply to your entity.

Example of an incomplete Year End Checklist:



USING THE CHECKLIST

You can access the 2024 year end checklist only while logged into the working year 2024. The tab pages operate similarly to the UAN bank reconciliation:

- Click Save and then Close if you need to exit the Year End Checklist. You can save the checklist even when it is incomplete and revisit it later.
- It is recommended (but not essential) to complete the steps in the order listed. You may work on some steps and then revisit them later in the process.
- You can view any of the steps at any time to see what remains left to complete.

<u>Icons used within the checklist</u>:



Complete - This green icon means the step is complete.



Incomplete - This red icon means at least one part of the step is incomplete.



Elick Tip - These small blue icons are clickable and will display helpful popup messages related to the area nearby them.



Caution! - This yellow icon applies to steps 4G & 4H. It does not necessarily indicate a problem but is there to draw your attention to important information to consider before closing. Carefully review the information in these steps!



= 'Year End Checklist is NOT complete (*red flag*)' means some steps are incomplete. Review the checklist for steps marked and complete them.



= 'Year End Checklist is complete (green flag)' means you have met the minimum requirements to close the year in UAN.

For your convenience, some of the or icons, when clicked on, will open a UAN menu or form applicable to completing the step or sub-step. For example, clicking on the red icon next to step '5-Bank Reconciliation' will open the Bank Reconciliation area.

CHECKLIST SUMMARY

- 1) UAN version 2025.1 or higher must be installed before the Year End Checklist will be accessible.
- 2) The UAN computer/calendar date must be in or after December 2024.
- 3) Temporary Mode must be open (see important notes in that section).
- 4) Year End Checklist: complete A-H:
 - A. All current batch transactions must be posted or deleted.
 - B. Select a Demographics & Debt submission type and enter values (when applicable).
 - C. Select the desired annual financial report type (Complete all steps related to the type selected).
 - D. Enter contact information and verify entity information.
 - E. Enter state-owned hardware tag numbers and entity addresses.
 - F. Enter next year's (2025) fiscal officer details (if applicable). Read the prior year reports removal notice carefully and mark the acknowledgment statement when you are ready.
 - G. Review open purchase orders (if any) and acknowledge their effect on the 2025 budget if you allow them to carry over.
 - H. Review unpaid payroll withholdings (if any) and acknowledge their effect on the 2025 budget if you allow them to carry over.
- 5) Post the bank reconciliation for December 31.
- 6) The UAN computer/calendar date must be in or after January 2025.

Finish–close the year. The closing process will create three backups:

- 1. 12/31/2024 UAN backup 2024 year end (to be retained by the entity)
- 2. 01/01/2025 UAN backup 2025 year begin (to be retained by the entity)
- 3. AFR- AOS backup (for submission to the Auditor of State)

STEP 1: INSTALL VERSION 2025.1

You must install UAN version 2025.1 (*the year end update*). Please note that installing it does *not* automatically open Temporary Mode or advance the application to 2025. If you require any prior version updates, contact UAN Support.

STEP 2: COMPUTER DATE

The UAN computer date (i.e. calendar date) must be in December 2024 or later.

STEP 3: OPEN TEMPORARY MODE

Temporary Mode includes *both* Accounting and Payroll. You must manually initiate the opening of Temporary Mode, but it will close automatically when you close the fiscal year 2024.

This step will verify that Temporary Mode is open. Temporary Mode allows you to work in both fiscal years 2024 and 2025 *before* closing the fiscal year 2024. Please note:

- Opening Temporary Mode is required as part of the year end process.
- Working in 2025 before closing 2024, (i.e. <u>using Temporary Mode</u>) is **OPTIONAL**.

UAN highly recommends using this outstanding feature! A list of its many advantages and details are in 'Appendix 1: Temporary Mode', starting on page 40. Please review that appendix before making a choice. For those Fiscal Officers who still choose not to use Temporary Mode, you have the option to complete the rest of the Year End Checklist before completing "Step 3 - Open Temporary Mode", and then you can immediately close fiscal year 2024.


Report Year

During *and after* temporary mode, you can produce reports for **either** 2024 **or** 2025 regardless of the computer date, *and* regardless of the work year selected at login. The reporting year (listed at the top left of most report areas) will default to the current work year but can be changed.


OPENING TEMPORARY MODE:

UAN Menu: General → Maintenance → Year End → Open Temporary Mode

When you click Open Temporary Mode, UAN will display a message: *Verifying database integrity, please wait*... Please be patient while the application takes a few minutes to verify that your financial data is internally consistent. If UAN detects any problems, it will display a message with directions. If it does not detect any errors, the following message will appear:



To continue, click OK and UAN will open a Year End Renaming form. *The following picture is an example of the form with sample withholding names.*




In this form, you can rename withholdings not specifically pre-set by UAN for fiscal year 2025.

IMPORTANT: This renaming is <u>only</u> possible when opening Temporary Mode - you <u>cannot</u> change existing withholding names <u>at any other time</u> during the year.

If you need more time to consider withholding name changes, click Cancel to stop the Temporary Mode opening process. If instead, you are ready to continue, enter the desired changes (*if any!*) under the "Revised Name" column. When you are finished, click Save.


Please be patient: The application will begin creating the data records required for the new year. Processing time for small to mid-size entities could be less than 1 minute – however, the processing time for *large* entities may be up to 10 minutes or more.

After the processing is complete, a message will display:




Read the message carefully and click OK to continue. UAN will automatically close.

Double-click on the UAN icon to reopen the application. Now that UAN is operating in Temporary Mode, you may select the work year upon login (as seen below):



Notice the buttons above the User Name: "Work Year: ● 2024 O 2025". Each time the User Login form opens in Temporary Mode, the work year will default to ● 2024. Select the year that

you would like to work in and then enter your user name and password. Click OK to log in, and a message will display:



Read the message carefully and click OK to continue. When UAN opens, notice that the top right of the main menu displays a Temporary Mode notification:



The work year that you selected on the User Login form will be displayed, as well as the date upon which 2025 will become unavailable on the login form (if 2024 has not yet been closed).

Reminder: Temporary Mode will close automatically when you close the fiscal year 2024.

STEP 4: YEAR END CHECKLIST

IF NEEDED, REOPEN THE YEAR END CHECKLIST:

General → Maintenance → Year End → Year End Checklist, then click Current Year

Complete checklist tabs A-H. *Reminder*: You do *not* have to complete these requirements in a particular order or in a single sitting.

4A - BATCH TRANSACTIONS

Before closing the year, you must post or delete all <u>2024</u> batch transactions. This section lists the number of remaining batch transactions and paths to each batch area beside the transaction type.

Accounting-Only clients – batch EFT, Wages, Withholding Payments and Withholding Adjustments do not apply to you.

EFT— If the EFT batch is Incomplete and you use the EFT Data Entry method, then you cannot close the year until you mimic the process of creating the batch files. For instructions, open the Payroll EFT Handbook by clicking (or typing in) the following:

Then scroll down the webpage to the section titled "Payroll Electronic Funds Transfer (EFT)". There you can open the handbook to review the Payroll EFT section - steps 2 & 4.

Important Reminders

All cash transactions (like posting interest revenue for the primary checking account) and related utility functions needed for the fiscal year should be posted *before* completing the annual financial report utilities (Step 4C) and *before* posting the 12/31 bank reconciliation (Step 5), to prevent having to repeat these steps.

Investment and/or secondary checking account balances in UAN should match the corresponding bank statement balances. You must enter all transactions <u>before closing the fiscal year</u>, including interest or fees posted at the bank on December 31.

Beginning with fiscal year 2024, *only* Regulatory annual financial statements can be submitted to AOS using the UAN application.

• Submit through UAN with AFR filing (recommended)

When filing AOS Regulatory statements, UAN recommends filing through the application since it will be considered your final submission once it is received by UAN i.e. those submitting through the UAN application *will not* be required to use the online Hinkle System for filing.


• Complete these requirements online (GAAP/FASB/OCBOA)

Select this type if you will be filing GAAP, FASB or OCBOA statements.


All non-regulatory filing types must be submitted online through the Hinkle System via the entity's AOS eServices login account within the deadline set by the Auditor of State's Office. UAN does *not* recommend this for any other circumstance for the majority of UAN clients. However, AOS provides a more comprehensive list of exceptions in which an entity might file online, as seen on their eServices website:

"If a UAN entity is a non-governmental, not-for-profit entity; did not maintain records in UAN for the entire reporting period; or chooses to report on a basis of accounting for which UAN cannot generate financial statements, the entity should submit a request to opt out of UAN filing."

An **override password** is necessary to select and save this submission type. UAN Support staff cannot provide the password. Log into your **AOS eServices** account to submit a **request through the Hinkle System** to opt-out. Once the opt-out is approved by the AOS, you will receive an override password from them. Then return to Checklist tab 4B and select this submission type. You will receive the following message:



Click OK to continue and the following form will open:



Enter the Hinkle System Override password and click OK. This will automatically change the status of tabs 4B and 4C to a 'Complete'.

Optional Web-GAAP Export: Non-regulatory filers can choose to use the Web-GAAP Export File option – now available in the UAN application – to create a file that can be uploaded to Web-GAAP to produce annual financial report information. That information can then be used to enter and submit online to the Hinkle System. To enable the Web-GAAP Export File option, you will need to first verify and/or edit certain account information under AFR - Fund Utility. For details, read 'Appendix 7: GAAP / FASB / OCBOA AFR Filing Submissions' starting on page 112.

Audit staff sometimes request various reports from the fiscal officer for their review before a formal audit. By selecting this option, UAN will automatically send these reports when submitting the annual financial reports. Click the blue question mark for more information.

WHEN USING THE 'AFR DEMOGRAPHICS & DEBT' LIST GRID

Input applicable items in the list with values/amounts 'as of' 12/31/2024.

SPECIAL DISTRICTS ONLY:

The grid list is intentionally blank since special districts, (e.g. fire, water & sewer, park, etc.) are required to choose a submission type, but are *not* required to enter additional data.

TOWNSHIPS, VILLAGES, AND LIBRARIES:

To meet the minimum technical requirement for completion of this section, townships and villages must enter a value in the 'Population' field while libraries must enter the 'Number of Patrons'.

You are required to enter all values applicable to the entity here for your final year end audit submission before the deadline set by the Auditor of State - financial penalties may be assessed for late filings.

Many values may not be available until after the end of the year. UAN recommends gathering information such as population, tax rate, assessed property tax valuation and debt (*only the items applicable to your entity*) as soon as possible so you are prepared to enter those values in UAN. By using Temporary Mode, you might gain some extra time to complete these items before closing the fiscal year within the deadline.

Please Note:

• Debt information must not include any premiums/discounts on debt insurance, nor any gains/losses on debt refunding or long-term compensated absences, claims, or pension liabilities. For guidance, contact the AOS Center for Audit Excellence at 1-800-282-0370.

• If you wish to verify the 'Calculated' amounts that automatically populate the grid, view two reports in the *UAN menu*: Accounting → Reports and Statements. Review the 'Final Appropriation Total' for all funds on the 'Appropriation Status' report and the 'Unencumbered Fund Balance' for the General fund on the 'Fund Summary' report.

For your convenience, the AFR Demographics & Debt tables applicable to townships is provided below (as they will appear on the Year End Checklist 4B tab). Village and library tables are on the next page.

4C - ANNUAL FINANCIAL REPORTS

Select the Annual Financial Report (AFR) Filing Type:

OCBOA Modified Cash Basis

Select if you will file OCBOA statements and the entity has at least one non-pooled investment.

OCBOA Cash Basis

Select if you will file OCBOA statements and the entity has zero non-pooled investments.

Regulatory

Select if you will file AOS Regulatory annual financial statements through UAN.

Beginning with fiscal year 2024, *only* Regulatory annual financial statements can be submitted to AOS using the UAN application. If you will be filing OCBOA Cash or Modified Cash for fiscal year 2024, select it here, and be sure to follow the instructions in section 4B - AFR Demographics & Debt starting on page 9, if you have not already done so.

ADD-IN NOTES IN UAN (REGULATORY AFR FILING)

All entities filing Regulatory statements are required to add-in the **Notes to the Annual Financial Statements**. UAN does not generate the Notes because there is nothing in the day-to-day software activities that would produce them. Instead, you prepare the Notes outside of UAN and then add them into the application. In some situations, you might add-in other supporting documents that you choose to submit or that an auditor requests.

The Notes & Documents section (on the right side of the page of Step 4C) will list the number of files currently added into UAN, or list it as incomplete as seen in the following image.



For steps to add-in Notes into UAN and AOS resources to help you prepare them, review 'Appendix 2: Year End Reports' starting on page 51.

WHEN TO USE THE AFR – FUND UTILITY (REGULATORY AFR FILING)

When 'Regulatory' is the filing type on tab 4C, the only required field is 'Notes & Documents'. However, this is only the case because UAN cannot detect whether your entity's situation calls for a few other report modifications. When applicable, these should be completed in the AFR Fund Utility:

UAN Menu: General → Reports & Statements → Year End → AFR – Fund Utility

The AFR-Fund Utility is ONLY necessary for Regulatory statements when:

- The entity has at least one custodial fund type.
- When it is necessary to 'map' at least one fund.

Custodial Funds

If your entity has any custodial-type funds, you must identify whether those funds should report as part of an External Investment Pool or Other Custodial on Regulatory AFR Statements. To view the two statements affected by this go to **UAN Menu**: General \rightarrow Reports & Statements \rightarrow Year End \rightarrow AFR – Regulatory Statements, select the year and then the (abbreviated) statement name:

- Combining Statement Proprietary and Fiduciary
- Combined Statement Proprietary and Fiduciary

Fund mapping:

When a fund is 'mapped to' another fund, it means the current fund's balance will be considered part of the selected fund's balance for the purpose of annual financial statements. Mapping is an option for miscategorized or ancillary (subsidiary) funds only. By default, funds are not mapped to other funds. **Most UAN entities will have no need to map any of their funds**. Clicking 'Map To' in the utility requires you to pick another fund that the current fund will be 'mapped to'. When a fund is mapped to another fund:

- The cash balance of that fund will be included in the 'Map To' fund for the purpose of annual financial statements only.
- The mapped fund takes on all characteristics of the fund it is mapped to.
- If the characteristics of a fund that it is mapped to are changed, the mapped fund is updated to match.
- The mapping information will not carry over to the next year. The proper fund will need to be added once the entity is in the new year.
- You can map several funds to one fund, but a fund cannot be mapped to a fund that is also mapped to another fund.
- The General Fund is not allowed to be mapped to another fund.

• You cannot map Governmental or Proprietary type funds to Fiduciary type funds (Fiduciary to Fiduciary is permitted when applicable).

A typical example is if the fiscal officer determines money was miscategorized in 2024, but it will not be corrected until the beginning of 2025. Mapping will allow the fund to be categorized correctly for the purposes of the 2024 annual financial reports. After 2024 is closed, the balance of the fund should be moved to the fund to which it was mapped. Similarly, if this option is used to map a fund to a completely new fund, the original fund balance should be moved to the new fund after closing the year. Another example is the possibility that an Unclaimed Monies fund balance might need to be reported in the fund that will eventually receive the money (usually the General fund). This can be achieved by mapping.

USING THE AFR – FUND UTILITY (REGULATORY AFR FILING)

UAN Menu: General \rightarrow Reports & Statements \rightarrow Year End \rightarrow AFR – Fund Utility

All funds – whether active or inactive – will be on the list. Checkmark the funds you would like to edit and click Edit.




Click Regulatory and the 'Edit AFR – Fund Utility' form will open. When editing multiple funds at the same time, use the navigation arrows in the bottom left corner of the form.

For example, six funds were selected here: 2 of 6 Dec. Click the arrows to advance back and forth between funds or move to the first or the last fund selected.


Custodial Funds

Identify how the fund assets will be reported on Regulatory Statements. This setting will only display for custodial funds:



Mapping:

Mapping should only be done when necessary. To map a fund, click the 'Map To' button and select the fund number that the current fund's balance will be considered part of for the purpose of annual financial statements. An example of fund mapping is in the image below:



Reset button

Located below the list of funds, the reset button will reset the funds you select to the UAN defaults.

4D - ENTITY & FISCAL OFFICER

If you closed the Year End Checklist while completing the AFR – Fund Utility, reopen it:

UAN Menu: General → Maintenance → Year End → Year End Checklist, click Current Year

Click tab 4D to enter your contact information and verify the fiscal officer's name and entity information. If you need to edit the fiscal officer name or entity tax IDs: UAN Menu: General \rightarrow Maintenance \rightarrow Entity Setup

4E - HARDWARE & MAILING

UAN Hardware Tags

Confirm or correct tag numbers from the state-owned hardware so that UAN can maintain an annual accounting of inventory. The form lists the numbers from UAN records. Click the cions for tag location descriptions and photos to verify these numbers are the same on the actual hardware tags.

<u>If UAN records are correct</u>, then mark the checkboxes ' My auditor tag matches UAN records' and ' My computer tag matches UAN records'.

If UAN records are incorrect, enter the correct tag number in the input field instead and leave the checkbox clear '□'. Note: During the closing process, UAN will check to confirm the accurate tag number format of any corrections that are input.

UAN Hardware Address:

Enter your hardware shipping address. This must be a physical location. <u>Do not enter a PO Box</u>.

Mailing Address:

Enter your mailing address – the location UAN should mail physical correspondence to you.

4F - NEXT YEAR FO & DETAILS

Select 2025's fiscal officer status and enter details if there are any known changes.

New Year's Fiscal Officer:

Same as current fiscal officer

Select if the current fiscal officer will be the new year's fiscal officer.

• Newly elected/appointed fiscal officer

Select if the fiscal officer in the new year is newly elected or newly appointed. Then fill in the 'as of' date, name, address, phone, and email address.

ACKNOWLEDGE THAT 2017 REPORTS WILL BE REMOVED

Following the AOS retention policy of maintaining only seven years of prior year reporting in the application, UAN will automatically remove all reports older than seven years. When you are ready, mark the checkbox:


'☑ I have read and understand that upon closing year 2024, the year 2017 will be removed from the application.'

You will be unable to retrieve any 2017 reports from UAN after closing fiscal year 2024.

If some reports are missing from your entity archives (non-UAN records), make sure to print and/or save them as PDF files before closing 2024. 'Appendix 2: Year End Reports' includes suggestions for 2024 'December 31st Year-To-Date Reports' and 'Payroll Specific Year End Reports' that you can use as a guide for which reports to archive for 2017 in addition to the AFR statements that apply to your entity.

Retrieving prior year reports to Print or Save to PDF

To access a prior year, open the report area, and click the 'Year' menu in the upper left corner. Select the fiscal year of the report you would like to print or PDF, as seen in the following example:



To save a prior year report as a PDF file, follow all the steps to print except, instead of clicking Print, click **Save PDF** located in the lower right corner of the report area. This will open a 'Save As' window, enabling you to save the file in any directory (i.e. folder). The default directory is C:\ UAN Efiles.

4G - CARRYOVER PURCHASE ORDERS

This section lists all purchase orders that are currently open. This is useful information to review so that you can close any that are no longer necessary, or reduce any with balances in excess of what will be necessary for 2025 payments.

Reminder: There are four purchase order types: PO Regular, PO Then & Now, BC Regular, and BC Super. *The instructions below refer to all types as 'purchase orders'*.

CLOSE PURCHASE ORDERS

Purchase orders that have a zero available balance will automatically close when you close the year. All others will carry forward if you do not close them. Be sure to post all 2024 payments against them before closing. If necessary, you may carry any purchase order into the new year.

UAN Menu: Accounting → Utilities → Purchase Order Utility. A five-minute video demonstration is available on the UAN website. To view, click or enter the following link and scroll to the 'Housekeeping' and then 'Purchase Order' section.

IMPORTANT

After a purchase order is carried over to the fiscal year 2025 (i.e. it is left open when you close the year 2024), it cannot be reduced, and closing it in 2025 will **not** increase the unencumbered balance available for appropriations in 2025. See the explanation below for details.

Carryover purchase orders reduce the unencumbered balances presented to the county auditor for purposes of calculating total resources available for appropriation. Therefore, closing unused purchase orders after they carry over into the next year will NOT increase the total resources available for appropriation until the fiscal year AFTER they are closed.

This rule prevents claiming inflated encumbrance amounts when filing for the Official Certificate of Estimate Resources. To avoid mistakenly restricting the entity's 2025 resources for the entire fiscal year, you should only allow encumbrances sufficient for meeting true outstanding obligations to carry over across years.

ADJUST (OR REDUCE) PURCHASE ORDERS AS NEEDED

Reduce purchase orders as needed. To avoid unnecessary carryover encumbrances, you can reduce purchase orders with an available balance in excess of what was or will be necessary for 2025.

UAN Menu: Accounting → Utilities → Purchase Order Utility, a five-minute video demonstration is available on the UAN website. To view, click or enter the following link and scroll to the 'Housekeeping' and then 'Purchase Order' section.

ACKNOWLEDGE THE EFFECT OF ANY CARRYOVER PURCHASE ORDERS

After thoroughly reviewing the list and adjusting and/or closing purchases (if necessary), and when you are ready to close the year, then mark the checkbox: "Open Purchase Orders: 🗹 I acknowledge the effect that any carryover items will have on the 2025 budget." This will change the tab icon from incomplete to complete.

The checkbox resets to unmarked whenever you close the form because later activity could change the carryover encumbrance. So you can wait until you are about to close 2024 to mark it.

4H - CARRYOVER WITHHOLDINGS

Current unpaid withholdings display in this section for your review. *This step does not apply to Accounting-Only UAN clients*. It is useful information to review so that you can:

- Confirm unpaid withholdings that **should carry over** for payment in 2025.
- Identify unpaid withholdings that **you should pay** in 2024.
- Identify unpaid withholdings that **you should clear** from the Payroll software in 2024 because they have been (*or will be*) paid through the Accounting software.

All withholdings left unpaid when closing 2024 will carry over to pay in 2025. Resources available for appropriations in 2025 will be reduced by the carryover unpaid employee and fringe benefit withholdings.

IMPORTANT

Clearing an unpaid withholding after it is carried over to fiscal year 2025 will NOT increase the new year's available resources (just like Purchase Orders, discussed above).

Carryover payroll encumbrances (unpaid employee share or fringe benefit withholdings, if applicable) reduce the unencumbered balances presented to the county auditor for purposes of calculating total resources available for appropriation. Therefore, clearing unpaid withholdings after they carry over into the next year will NOT increase the total resources available for appropriation until the fiscal year AFTER they are closed.

This rule prevents claiming inflated encumbrance amounts when filing for the Official Certificate of Estimate Resources. To avoid mistakenly restricting the entity's 2025 resources for the entire fiscal year, you should only allow payroll encumbrances sufficient for meeting true outstanding obligations to carry over across years.

Note: Carryover balances calculate <u>when closing 2024</u>, *not* when opening Temporary Mode. You CAN still pay or clear carryover withholdings during Temporary Mode.

If you have identified items that you think probably should be paid or cleared in 2024, you should investigate further so that you can complete those steps (if necessary) before you close 2024. UAN recommends reviewing the short video 'Evaluate Unpaid Withholdings'. Click or enter the link below and scroll to 'Housekeeping'.

ACKNOWLEDGE THE EFFECT OF ANY CARRYOVER PAYROLL ITEMS

After thoroughly reviewing the list and clearing any unpaid withholdings that you determine should not carry over (if applicable), when you are ready to close the year, then mark the checkbox: "Unpaid Withholdings: ☑ I acknowledge the effect that any carryover items will have on the 2025

budget." This will change the tab icon from incomplete to complete.

The checkbox resets to unmarked whenever you close the form because later activity could change the carryover encumbrance. So you can wait until you are about to close 2024 to mark it.

STEP 5: BANK RECONCILIATION

Important Reminders

You cannot forward-date bank reconciliations, thus you cannot add the December 31 bank reconciliation until the computer date (calendar date) is **on or after** 12/31/2024. Please review the *Important Reminders* listed on page 8 of this booklet before posting this bank reconciliation.

POST THE DECEMBER 31ST (YEAR END) BANK RECONCILIATION

You must post the December 31 (*year-end*) bank reconciliation before closing the year. The steps to add and post it are just like any other bank reconciliation.

UAN Menu: Accounting→ Transactions→ Bank Reconciliation, then click 'Need Help' or FAQs for more information.

IMPORTANT: you must date the year end bank reconciliation 'as of' 12/31.

VOIDING THE YEAR END BANK RECONCILIATION (IF NEEDED)

If the December 31 bank reconciliation is in batch (saved but not posted), it is available to edit or delete like any other bank reconciliation in Accounting > Transactions > Bank Reconciliation.

When necessary, you can void a posted December 31 bank reconciliation. Voiding the bank reconciliation changes the status of all items marked cleared and/or voided on that reconciliation back to 'outstanding' and deletes the reconciliation.

UAN Menu: Accounting → Utilities → Bank Reconciliation Utility

Place a checkmark beside the 12/31 bank reconciliation and click Void. A voided bank reconciliation will no longer appear in the list.

TIMING OF YEAR END REPORTS

You may print year end reports before or after closing 2024. If you choose to print before closing, first read a thorough explanation in the overview of Appendix 2: Year End Reports, starting on page 44 to avoid issues that would require you to re-print the same reports later.

STEP 6: COMPUTER DATE

The computer/calendar date must be on January 1, 2025, or later before you can close 2024.



FINAL REVIEW

Review all tabs in the year end checklist for accuracy and address any that have the incomplete status icon. After you have completed the minimum technical requirements to close the year, the Finish flag icon will change from red to green indicating the checklist is complete.

VERIFY W-2 EMPLOYEE SETUP & WITHHOLDING INFORMATION

Edits to the following employee and withholding areas will not automatically update 2024 W-2 forms if done in work year 2025 and more time-consuming manual edits will be necessary.

- Employee names, social security numbers, and addresses.
- Local tax abbreviations and school district numbers

Save time by verifying and entering any needed corrections *before closing fiscal year 2024*. See instructions on the first two pages of Appendix 3: W-2 & W-3 Forms starting on page 72.

PRINT YEAR END REPORTS & TAX FORMS BEFORE CLOSING (RECOMMENDED)

You may print year end reports <u>before or after</u> closing the year. Detailed instructions are in Appendix 2: Year End Reports starting on page 44.

Important: Some year-end reporting requires manual input into UAN or external add-in documents. You **cannot** submit separate document files. You must complete the manual input and add-in steps that apply to your entity, for UAN to compress it into the AFR-AOS Backup — which is a single file created during the year-end closing that you choose to submit automatically by internet or disc for mailing. You are required to complete all steps prior to the final year-end audit submission (AFR-AOS Backup) and UAN must receive it **before the deadline** set by the Auditor of State - financial penalties may be assessed for late filings.

Recommendation: By using Temporary Mode, you might gain some extra time to complete the items above before closing the fiscal year.

CLOSE THE YEAR

If you exited the Year End Checklist while completing the requirements above, reopen it:

UAN Menu: General → Maintenance → Year End → Year End Checklist

Click Current Year

ACKNOWLEDGE THE EFFECT OF ANY CARRYOVER PURCHASE ORDERS

Select 4G-Carryover Purchase Orders. Review the list one more time and when you are ready to close the year, mark the checkbox: "Open Purchase Orders: **I** I acknowledge the effect that any carryover items will have on the 2025 budget." This will change the tab icon from incomplete to complete.

ACKNOWLEDGE THE EFFECT OF ANY CARRYOVER PAYROLL ITEMS

Select 4H-Carryover Withholdings. Review the list one more time and if you are ready, mark the checkbox: "Unpaid Withholdings: **I** I acknowledge the effect that any carryover items will have on the 2025 budget." This will change the tab icon from incomplete to complete.

SELECT THE FINISH (CLOSE THE YEAR) TAB

The flag should be green, meaning the minimum technical requirements are complete and the 'Close 2024' button should be accessible (but do not click it yet. Continue with the instructions). Note: If the button is shaded gray (i.e. *if you click it, nothing happens*), that means that some steps are incomplete. Review the tabs with the incomplete status icon After addressing these issues, the Finish flag icon will change from red to green.

CERTIFY THE AFR SUBMISSION AND THE ENTITY'S RESPONSIBILITIES

Carefully read the Finish (Close the Year) tab page. When you are ready to certify the accuracy and completeness of the AFR submission and the entity's responsibilities, checkmark the acknowledgment statement. 'I I affirm ...'

CLICK THE CLOSE 2024 BUTTON

You will be unable to retrieve any 2017 reports from UAN after closing fiscal year 2024.


Final notice: If some reports are missing from your entity archives (non-UAN application records), make sure to print and/or save them as PDF files <u>before closing 2024</u>. See page 19 for details.

Prepare for extra processing time to remove the prior years


If you are approaching your 8th year with UAN, you will notice the processing time will be longer than previous years. This is due to the extra time it takes to delete 2017 data in compliance with the Auditor of State's 7-year retention policy. For example, at entities with a large volume of transaction history, the closing may require up to 30-45 minutes.

Click Close 2024 to begin the process.

After a moment of processing (verifying database integrity), you should receive this message:




Click OK if you wish to continue and you will receive this message:




Click OK if you wish to continue. If UAN does not detect hardware tag errors, the application will guide you through creating backups and you can skip to the directions starting on page 28.

Potential error messages: UAN confirms whether the Auditor of State tag number entered in 'Step 4E – Hardware & Mailing' is valid. <u>If it is not valid</u>, the following message will open:



Click OK. Now UAN will check the Computer tag number entered in 'Step 4E – Hardware & Mailing'. <u>If it appears to be invalid</u>, the following message will open:



Follow the directions in the message. If needed, correct the Auditor and/or Computer tag numbers entered on tab 4E - Hardware & Mailing. Then click the Finish (Close The Year) tab again and click 'Close 2024' to repeat the above steps to close the year.

After you resolve hardware tab errors (*if needed*), the application will guide you through creating three backups described in the directions starting on page 28.

1 - UAN BACKUP - 2024 YEAR END

The entire year's activity must be backed-up before fiscal year 2024 will close. After following the steps on the previous page, a message will appear. Read the message carefully and click OK. The first of the three backup forms will open '*UAN Backup – Year End 2024 – Backup 1 of 3*'.

This form operates exactly as any other UAN Backup required throughout the year. Choose the backup destination, insert the desired media (*CD*, *DVD*, *flash drive*, *network drive*, *or other*), and click Start. UAN strongly recommends that you use a blank CD or DVD and that you do not reuse it later for any other purpose.

Reminder: If needed, detailed instructions for UAN Backups are in the Accounting & General Manual under the General → Maintenance → Backup section.

When this backup is complete, the fiscal year 2024 closes in UAN and a message will open with information about the next backup. If the backup destination was a CD or DVD, then you should immediately remove the disc and label it so that it is clearly distinguished from other discs.

Suggested label:

Do NOT send this backup to UAN as your 2024 audit submission.

This backup is not valid for audit submission (i.e. AFR – AOS backup) and does not satisfy your legal filing deadline! Instead, the entity should retain it and keep it separate from your backup rotation cycle. The backup media should be stored in a secure place, preferably off-site.

2 - UAN BACKUP - 2025 YEAR BEGIN

As noted on the previous page, after the first backup is complete a message will open with instructions for completing the second backup. Read the message carefully and click OK. The second of the three backup forms will open 'UAN Backup - Year Begin 2025 - Backup 2 of 3'.

This form also operates exactly like any other UAN Backup. Choose the backup destination, insert the desired media (*CD*, *DVD*, *flash drive*, *network drive*, *or other*), and click Start.

When the backup is complete, the backup form will close and a message will open with information about the next backup. If the backup destination was CD or DVD, then you should immediately remove the disc and label it so that it is clearly distinguished from other discs.

Suggested label:

Do NOT send this backup to UAN as your 2024 audit submission.

This backup is not valid for audit submission (i.e. AFR – AOS backup) and does not satisfy your legal filing deadline!

3 - AFR – AOS BACKUP FOR THE 2024 AUDIT SUBMISSION

As noted on the previous page, after the second backup is complete a message will open with instructions for completing the third backup. Read the message carefully and click OK. The last of the three backup forms will open 'AFR - AOS Backup - Year End 2024-Backup 3 of 3'.

You must choose a backup destination, either Internet Submission (instructions start below) or Postal Submission (instructions start on page 33). UAN recommends internet submission for entities that have access to a good high-speed internet connection.

INTERNET SUBMISSION


Make sure the computer has an internet connection. Select '● Internet Submission – Active Connection Required.' Then click Start and the backup form will begin the process. After it prepares the backup for internet upload, a file-submission progress message will open as follows:



UAN will automatically upload the file to the AOS Hinkle System i.e. there is no need to login to a website or search for a file for upload. Please be patient. The amount of time it will take to upload the file can vary significantly depending on your internet speed and the size of the file. Entities with high-speed internet service can expect uploading the file to take 1-5 minutes for a file under 50MB, 5-10 minutes for 50-100MB files, or 10-30 minutes for files over 100MB. For entities that use the very slow 'dial-up' internet (i.e. not a high-speed internet service), UAN recommends mailing the file on a disc (see option #2).


Please note: When you browse websites, you are "downloading" information, but when you transmit a file off the computer to AOS, you are "uploading" information. Internet upload speeds are typically 1/10th as fast as download speeds, so even though you may have a "high-speed internet" service that does not necessarily mean you have "high-speed uploads" as well.

When the upload is complete, the following message will open:




Carefully read the message and click OK.

Note: <u>If the backup fails to upload</u>, a status message will appear in the backup form "Backup Failed. Please try again or contact UAN for assistance." Confirm or establish an internet connection and click Start to try again. If the upload continues to fail, you can either change the type to 'Postal Submission' to create a disc for mailing or close the form and try again after establishing a good internet connection. When closing the form after a failed attempt, the following will open:



A '2024 is now closed' confirmation message will display:



Carefully read the message and click OK – the application will log out.

Be sure to read "Meeting Annual Reporting Requirements for the Auditor of State" starting on page 36 concerning the deadline requirements and steps to confirm the status of your submission. However, you should first confirm that the UAN application is operating in the new year and that the correct fund balances have carried forward – continue to page 35 for details.

POSTAL SUBMISSION

If the UAN computer is a laptop, connect the external CD/DVD drive and insert a blank disc in the CD/DVD tray.

Note: Windows may automatically open a File Explorer window – please close the window. Alternatively, Windows may prompt with a message to choose what to do with the disc drive – similar to the message below.




If there is an option to cancel, then select it. Otherwise, you may choose either 'take no action' or open the folder and then close the folder immediately.


Select '● Postal Submission – CD or DVD'

If needed, click the Browse button to open a 'DriveSelect' form that lists the current disc drive letter that Windows has assigned to the disc drive. Select the drive and click OK to close the DriveSelect form.



Be sure to read "Meeting Annual Reporting Requirements for the Auditor of State" starting on page 36 concerning the deadline requirements and steps to confirm the status of your submission. However, you should first confirm that the UAN application is operating in the new year and that the correct fund balances have carried forward – continue to page 35 for details.

STEPS AFTER CLOSING THE FISCAL YEAR

You have completed the year-end closing process, but do not forget these important steps.

CONFIRM THE UAN APPLICATION IS IN THE NEW YEAR

Log into UAN – the Login form should no longer have a 'Work Year" option. Confirm that there is no longer a Temporary Mode notification in the top right corner and that Year: 2025 displays in the status bar in the bottom right corner of UAN (to the left of the current date).

If 2024 displays in the status bar instead of 2025, then you have *not* successfully closed the year. Carefully repeat the closing process outlined in this booklet, starting on page 25. For further assistance, contact UAN Support at uan support@ohioauditor.gov or 1-800-833-8261.

CONFIRM FUND BALANCES CARRIED FORWARD

Print the Cash Summary by Fund for December 2024 and for January 2025 to confirm the fund balances carried forward correctly. Compare the 'Fund Balance 1/1/2025' column on January 2025's report to the 'Fund Balance 12/31/2024' column on December 2024's report.

UAN Menu: Accounting \rightarrow Reports & Statements \rightarrow Fund Reports, select Cash Summary by Fund, the year and month.

YEAR END BALANCE CERTIFICATE

You can use the Budget software provided by UAN to create the Year End Balances Certificate for submission to the county auditor – see page 108 for details. Using UAN Budget to prepare this certificate is optional.

MEETING ANNUAL REPORTING REQUIREMENTS FOR THE AUDITOR OF STATE

Each local government is required to submit its Annual Financial Report to the Auditor of State within <u>sixty (60) days of the end of the fiscal year</u>. Meeting this requirement for UAN members occurs when the 2024 AFR internet upload (or disc) containing the end-of-year filing data of the government is received by UAN.

Reminder: the final 2024 AFR-AOS Backup internet (or disc) submission must include *all that is applicable for your entity*: Hinkle System data entry for Demographics & Debt, other manually input reports, and compressed add-in documents. See the important note on page 24 for details. Financial penalties may be assessed for late filings.

CONFIRMING THE STATUS OF YOUR SUBMISSION

Whether your submission was by internet or mail, you should confirm the filing status on the Hinkle System through the Auditor of State's Customer eServices website. Please allow 5 business days with postal or 3 business days with the internet for the Hinkle System to process the file. For your convenience, there are two menu shortcuts built into the application that will take you directly to the eServices website. Connect your computer to the internet (if needed), then click one of the menu shortcuts listed:

UAN Menu: General \rightarrow Maintenance \rightarrow Year End \rightarrow AFR – Filing Status *OR* General \rightarrow Reports & Statements \rightarrow Year End \rightarrow AFR – Filing Status

Either option will open the AOS eServices page with a 'Login' button. To access the website from a different computer, connect to the internet and type the following into the web browser:

https://eservices.ohioauditor.gov

Clients that are registered and verified with the Auditor of State's Office can access the eservices portal 24/7. The Email that you need to enter when logging in is the email your entity already has on file with AOS Fiscal Department. If you have trouble logging into your eServices account, please send an email to eServices@OhioAuditor.gov

If you are required to enter a Customer Number, it is the same as the Auditor of State (AOS) account number located on any AOS invoice for your entity. It is five characters long and follows the format: two numbers, one letter, and two numbers.

After logging into the eServices account, the following steps will allow you to view the annual financial statements and notes. Reminder: this is for viewing only; your entity does not complete any additional steps on the website to file with the Hinkle System.

- Step 1: On the eService's home screen, select the 'Hinkle System'.
- Step 2: On the Hinkle System page, there will be a table. Within the table are the year end filings that have been submitted to the Hinkle System. To review the 2024 year end filing, select 2024 in the blue font. The Financial Data Viewer page will display.
- Step 3: On the Financial Data Viewer page, select 'View All Details'. The Filing Details page will display.
- Step 4: On the Filing Details page, select the PDF document icon located to the right of 'Uploaded Document' to open it. Note: If the document does not open right away, look for a 'Downloads' message box on the browser screen asking if you want to Open, Save, or Cancel the document. Click Open to display the document.
- Step 5: The PDF document will contain the annual financial report statements listed first, followed by the notes to the financial statements at the end. Scroll to the end of the document to confirm that all of the notes pages that you prepared are included in the PDF.

Important: If the notes on the AOS eServices website are missing, incorrect, or incomplete, then first confirm that you have the final version of the notes that you prepared on the UAN computer. Next, repeat any of the steps that may be necessary for 'AFR - Notes & Documents', starting on page 51. Then follow 'Appendix 8: Recreate AFR - AOS Backup If Needed' starting on page 115 to recreate and resubmit the AFR - AOS Backup within the AOS deadline, as listed on page 36.

PUBLICATION REQUIREMENTS

Each local government is required to publish a notice in the local newspaper that the Annual Financial Report is complete and that the report is available at the office of the fiscal officer. <u>The notice needs to be published at the time the UAN member files their Annual Financial Report with the Auditor of State</u>, which is accomplished by submitting the 2024 AFR – AOS backup by internet (or disc) submission to the Auditor of State.

OHIO CHECKBOOK AUTHORIZATION

Through a partnership between the Ohio Treasurer and the Auditor of State, local governments using UAN can choose to have UAN transmit their checkbook-level transactions to OhioCheckbook.gov in a quick, easy, and convenient process. When authorized by the fiscal officer, UAN will use the 2024 Annual Financial Report (AFR) data submitted to the Auditor of State (through UAN online or by disc) to submit the data to the Ohio Checkbook on your behalf.

UAN *will not* submit any data to Ohio Checkbook without your specific authorization for each fiscal year (previous fiscal years may also be authorized). You can authorize fiscal year 2024 through UAN *only after* closing the fiscal year, submitting the AFR data to UAN, and confirming the submission is successful by reviewing the filing status on the Auditor of State's Customer eServices website.

<u>This is not a UAN requirement</u>; those entities that choose to submit financial information to the Ohio Treasurer can take advantage of this convenient option. For more information, click or type in the **UAN website** home page into your internet browser:

https://uanlink.ohioauditor.gov/

Then select the **Resources** menu and then **Ohio Checkbook** to view instructions.

PRINT YEAR END REPORTS & TAX FORMS (IF NOT YET COMPLETE)

If, before closing, you did not print the year-end reports and applicable tax forms (W-2s, etc.). Instructions start on page 44, Appendix 2: Year End Reports.

OTHER CONSIDERATIONS FOR THE NEW YEAR

For suggestions on beginning the year, see *Appendix 4: New Year Accounting Procedures* and *Appendix 5: New Year Payroll Procedures* starting on page 96. *Reminder*: Revenue and appropriation budgets are set to zero when the year is closed. However, if you logged into the work year 2025 during Temporary Mode and entered your 2025 Revenue Budgets and/or Temporary appropriations, those will remain in place after you close 2024.


2024 Year End Procedures - Appendices -



APPENDIX 1: TEMPORARY MODE

UAN version 2025.1 (the year end update) includes Temporary Mode. In order to prepare for the use of this feature, please carefully review all of the important information provided in this appendix.

Temporary Mode allows you to work in both fiscal years 2024 and 2025 *before* closing fiscal year 2024, which provides many potential advantages. Opening Temporary Mode is a *required* step in the year end process, but working in 2025 before closing 2024 is *completely optional*. During Temporary Mode, you may select the work year upon login. See below:



This appendix is organized into four parts:

Part A - Advantages of Temporary Mode

Part B - Dating Rules in Temporary Mode

Part C - Accounting in Temporary Mode

Part D - Payroll in Temporary Mode

Important definitions:

Fiscal year - The fund accounting budgetary year

Calendar year - The year of the actual live date/computer date

Work year - The fiscal year you have selected to work in (see picture above)

Please install 2025.1 as soon as you receive it. Note that installing it does not *automatically* open Temporary Mode or advance the application to 2025.

PART A - ADVANTAGES OF TEMPORARY MODE

Temporary Mode is available for sixty days after December 31, 2024 and includes both the accounting and payroll modules. You must manually initiate the opening of Temporary Mode, but it will close automatically when you close 2024.

While the calendar year is still 2024, not only can you continue with your typical day-to-day work for December 2024, you may *also* log into work year 2025 where you can enter:

- Revenue budgets for fiscal year 2025
- Temporary appropriations for fiscal year 2025

- Purchase Orders that apply to the fiscal year 2025 appropriations
- Payroll maintenance changes (*employee setup or withholding rates*) that will apply to the first wages posted in January 2025

While the calendar year is 2025, you will be able to perform your typical day-to-day work for 2025, *and* also log into work year 2024 where you can enter:

- Final 2024 interest receipts from checking accounts or investments
- Any electronic payments made before the end of the calendar year 2024
- *Most utility adjustments or other corrections that should apply to the fiscal year 2024*
- The December 31st bank reconciliation (after receiving your final bank statement)

PART B – DATING RULES IN TEMPORARY MODE

The rules that have governed post dates throughout 2024 still apply during Temporary Mode:

- Just as before, you can never *backdate* printed warrants in UAN; therefore, you cannot print warrants with a 2024 post date after the calendar date has passed December 31, 2024. However, remember that receipts and electronic payments *may* be backdated to reflect the actual calendar date that online (or phone) transactions were made, in order to be cleared on the correct bank reconciliation.
- Also just as before, you can *forward* date any payments up to thirty days beyond the calendar date <u>within the work year</u>. Consequently, in order to post transactions in the fiscal year 2025, you must be logged in to the work year 2025.

The only dating restriction specific to Temporary Mode is that 2025 transactions cannot be dated beyond the Temporary Mode period (i.e. sixty days after December 31, 2024). In other words, in order to post transactions dated March 1, 2025 or later, you must first close the fiscal year 2024.

Warning! All online or phone payments that you make in the calendar year 2025 must be posted in the work year 2025; do not improperly backdate such 2025 payments into the fiscal year 2024.

PART C - ACCOUNTING IN TEMPORARY MODE

1. Temporary Appropriations

Be prepared! Your governing board should adopt 2025 temporary appropriations by December 31, 2024 in order to authorize encumbrances and expenditures on and after January 1, 2025. Temporary appropriations should include all expenses you may incur throughout the **first** quarter of the year. In Temporary Mode, you may enter temporary appropriations for the fiscal year 2025 prior to the closing of fiscal year 2024.

2. Permanent Appropriations

UAN Temporary Mode does not change the proper legal procedures for adopting permanent appropriations. This means that your governing board should adopt permanent appropriations only *after*:

- A. Fiscal year 2024 has been reconciled and closed
- B. Fund balances and carryover encumbrances have been certified to the county auditor
- C. The Amended Official Certificate of Estimated Resources has been received

After you add your revenue budgets into UAN (verifying that they balance, by fund, with the sum of the Taxes and Other Sources columns on your Amended Certificate), then you can add your permanent appropriations into the software. You must enter revenue budgets before entering the permanent appropriations - otherwise, your appropriations will be limited to your unencumbered January 1, 2025 fund balances.

<u>Warning!</u> Do not enter permanent appropriations for the fiscal year 2025 prematurely, i.e. prior to reconciling and closing the fiscal year 2024 (*since you would not yet be able to accurately certify your fund balances and carryover encumbrances*). If you **do** enter appropriations prematurely, and subsequently post new payments in the fiscal year 2024, you could potentially reduce the resources available for the fiscal year 2025 below what you had appropriated. *This is a violation of the Ohio Revised Code*.

PART D - PAYROLL IN TEMPORARY MODE

1. 2025 Wage Appropriations

As mentioned previously, **you must** enter 2025 appropriations before you will be able to post any 2025 payments (*wages*, *withholding*, *or accounting payments*). Therefore, your governing board must adopt temporary appropriations if you will need to post a 2025 payroll prior to the adoption of permanent appropriations.

2. Payroll Maintenance

Payroll setup changes that are entered while logged into the work year 2024 will also update the 2025 setup. For example, if you add a new school tax while logged into the work year 2024, that withholding will also be available when you log into the work year 2025. However, an important distinction is that maintenance changes entered while logged into the work year 2025 will not apply backward to 2024. Warning! As always, when updating any employee, be mindful of the effective date of the change; i.e. do not prematurely edit your employee setup. Also, be mindful of any changes in tax rates that will apply to the first wages posted in the fiscal year 2025 (regardless of the pay period).

3. Calendar Year 2024

If you open Temporary Mode while the calendar date is still in 2024, you can continue to work in the fiscal year 2024 to post wages and withholding payments due to be paid that year. You may also log into the work year 2025 to make any necessary changes to employee earnings or withholdings applicable to the first payments to be posted in the fiscal year 2025 (and, if required for your payroll schedule, begin posting the first 2025 payments).

4. Calendar Year 2025

After the calendar date is January 1, 2025 or later, any remaining unpaid 2024 withholdings will carry over for payment in the fiscal year 2025. However, you will still be able to log into the work year 2024 to post any electronic payments that you paid during the calendar year

2024 but neglected to post in UAN at that time. Such items must be posted in the work year 2024 in order to be cleared on your December 31 bank reconciliation. **Warning!** All online or phone payments that you make in the calendar year 2025 must be posted in the work year 2025; do not improperly backdate such 2025 payments into the fiscal year 2024.

5. Withholding Liabilities and Reporting (Reminder)

OPERS and OP&FPF reporting and remittance months for wages are determined by *pay period end dates*, while Federal, State, School, and Local tax liabilities are instead determined by *paycheck post dates*. Example: Wages with December 2024 pay period end dates posted in January 2025 will be included on the OPERS and/or OP&FPF reports for December 2024, but also correctly recognized as 1st quarter 2025 Federal, State, School & Local tax liabilities.

6. You cannot do the following in Temporary Mode in Payroll:

- a. Remove or Delete any payroll items in either work year.
- b. Post Wage Reallocations or Wage Adjustments in the work year 2025.
- c. Clear Unpaid Withholdings in the work year 2025.
- d. Use the Withholding Overpayment utility in the work year 2025.

After the fiscal year 2024 is closed, these actions will be available again for the fiscal year 2025.

APPENDIX 2: YEAR END REPORTS

OVERVIEW

You may print year-end reports **before** *or* **after** closing the year. If you choose to print them before closing the year, <u>make sure you have completed all transactions and utility adjustments</u>, and <u>post your final December 31 bank reconciliation</u>. Otherwise – if you complete any of those activities *after* printing the year-end reports, many of those reports will need to be re-printed.

Important Note: Some year-end reporting requires manual input into UAN or external add-in documents. You cannot submit separate document files. You must complete the manual input and add-in steps *that apply to your entity*, for UAN to compress it into the AFR-AOS Backup. You are required to complete all steps prior to the final year-end audit submission (AFR-AOS Backup) and UAN must receive it before the deadline set by the Auditor of State - financial penalties may be assessed for late filings. These include the two items with asterisks "*" below and 4B - AFR Demographics & Debt (page 9).



Printing 2024 reports after closing the year or while in Temporary Mode work year 2025

You do not have to log into the work year 2024 to print 2024 reports. To print from a prior year, open the report area and click on the 'Year' menu in the upper left corner and select the fiscal year of the report you would like to print. As seen in the following example:




Saving reports in Adobe PDF file format

Year end reports (except for 1099/1096, W-2 and W-3 forms) can be saved as a file in Adobe PDF file format (PDF). To save a report as a PDF file, follow all of the normal steps to print except instead of clicking Print, click **Save PDF** located in the lower right corner of the report area. This will open a 'Save As' window, enabling you to save the file in any directory (i.e. folder). The default directory is C:\ UAN Efiles.

Other 'Save As' Window Options

To save the file to a different folder, click the shortcuts listed in the left pane of the window. Based on your selection on the left, sub-folders will display in the right pane of the window. If needed, continue to open the folders on the right (double-clicking) until you have navigated to the folder of your choice. Another option is to click the arrow to the right of the folder path located at the top of the 'Save As' window to open a menu where you can browse to recently used folders. To change the file name, type it in the 'File name' field:



AFR REQUIRING MANUAL INPUT

Some annual reports require financial data that you would not input in the normal course of the year, but you should input annually. These may include:

- Cash/Other Assets Not Recorded
- Cash Reconciliation
- Schedule of Debt Service
- Schedule of Outstanding Debt

It is possible that none of these reports may apply to your entity. *Skip those that do not apply*. However, *all applicable reports* are required to be included in your final year end audit submission before the deadline set by the Auditor of State - financial penalties may be assessed for late filings.

Recommendation: By using Temporary Mode, you might gain some extra time to complete these items before closing the fiscal year.

UAN Menu: General \rightarrow Reports & Statements \rightarrow Year End \rightarrow **All four reports** list in the menu and have options to Print, Display, or Save PDF once you input data.

CASH/OTHER ASSETS NOT RECORDED

Does the entity have any cash or other assets that belong to the entity that is not on its books? Some examples of cash not recorded that you might enter on this report:

- Money with a financial institution for servicing debt
- Money held in escrow for construction
- Money held by a third-party administrator servicing claims for a self-insurance program
- Money held in a deferred compensation program under − 26 USC § 457
- Money held in segregated accounts by other government officials
- Money held by a trustee to satisfy the covenants of a bond indenture
- Money in a payroll clearing account

If necessary, click Add to open the form. Enter the account number, institution name, description, and asset amount. Click Save and repeat these steps for all accounts.

CASH RECONCILIATION

This statement compiles information regarding depository balances (checking accounts) and investment information (treasury bonds, certificates of deposit, and other investments). Complete, *if applicable*, only after posting the December 31, 2024 bank reconciliation.

You are only required to enter data for this statement if your entity has one or more of the following segregated accounts i.e. accounts not included on the books or financial statements of your government. Possible segregated account types for input:

- Bond and Coupon Clearance Account (Not held in Pool)
- Payroll Clearing Account (Not held in Pool)
- Retainage Accounts (Not held in Pool)
- Debt Accounts (Related to Bond Indenture and Not held in Pool)
- Other Outside Accounts (Not held in Pool)

The balances entered should be after considering all reconciling items including outstanding checks. After you print this report, compare the Cash Reconciliation statement to the Fund Status report. If there are any differences, contact UAN for assistance in locating the discrepancy.

You can export the Cash Reconciliation to an Excel spreadsheet. Complete the form and click **Export** and a file will save to C:_UAN_Efiles. Use Windows File Explorer to browse and open the spreadsheet. It is designed to make it easier to incorporate information from this report into the Notes of the Annual Financial Statements.

SCHEDULE OF DEBT SERVICE

This schedule shows the <u>combined</u> outstanding principal and interest of all debt <u>for the years</u> <u>following December 31, 2024</u>. Each year that you enter should show the <u>combined</u> principal and <u>combined</u> interest for all scheduled debt payments in that year. However, you must retain the detailed information with your records for all debt service to maturity, since this information is subject to review during your audit. You should be able to obtain the information required for this debt schedule from your files or the lender.

Click Add and starting with 2025, enter the combined principal and combined interest for all outstanding notes and bonds for that year. Click Save, enter 2026 and then enter the combined principal and combined interest for all outstanding notes and bonds for that year. Continue this format for the first five years. After the first five years, group the remaining years into five-year sets of principal and interest. Repeat this process for all five-year sets until all debt maturity is reached. Make note that this is also the same format used in the Notes to the Annual Financial Statements. Please review the example that follows:

FAQ: Can I enter the same data from the 2023 Schedule of Debt Service's year end reports?

No, you cannot because the first year on the 2023 Schedule of Debt Service is not reported on the 2024 Schedule of Debt Service. Each year you must report the remaining debt payments until

maturity starting with the next fiscal year. If you have more than five years until all debt is paid the five-year sets from last year are not the same; every year, the grouped years are different. In addition, you may have issued more debt that must be added to the compiled information.

SCHEDULE OF OUTSTANDING DEBT

You must describe all debt activity for 2024 on this schedule with each note or bond described <u>as</u> <u>a separate item</u>. You must retain detailed information in your records for each outstanding debt pertaining to 2024, as this information is subject to review during your audit. If necessary, you should be able to obtain the information required for this schedule from your files or the lender. Click 'Add' to start with the first note or bond to enter.

** Continue to the next page to view two examples **

SCHEDULE OF OUTSTANDING DEBT – EXAMPLES:

Example A: In 2023 the government had a \$25,000 note issued for a truck. In 2024, the government paid \$5,000.00 of principal on this note. Enter the data like this:

AFR - NOTES & DOCUMENTS

UAN does not generate certain AFR documents (whether required or optional) when there is nothing in the day-to-day software activities that would produce them. Instead, you can prepare these documents outside of UAN and then add them into the application.

You *cannot* submit separate files. You are required to add all external documents applicable to the entity into UAN in order for UAN to compress* them into the AFR-AOS Backup — which is a single file created during the year end closing that you choose to either submit automatically by internet or to a disc for mailing. You are required to complete all steps prior to the final year-end audit submission (AFR-AOS Backup) and UAN must receive it *before the deadline* set by the Auditor of State - financial penalties may be assessed for late filings.

*File Compression is a technology that enables you to submit just *one file* (the AFR-AOS Backup) that will contain all your annual financial statements — including all add-in documents. A compressed file contains one or more files that are smaller than their original file sizes. This makes internet uploading faster and easier, and when applicable, it allows more data to be stored on a disc. So, as long as you follow the steps to add the files into UAN *before* closing the fiscal year, the files will compress into the AFR-AOS Backup.

Recommendation: By using Temporary Mode, you might gain some extra time to complete these items before closing the fiscal year.

Regulatory – Required and Optional add-in documents:

- Required: Notes to the Annual Financial Statements
- Supporting documents that you choose to submit or that audit requests (when applicable).

Instructions for saving and opening the AOS shells:

After opening the applicable web page, scroll to the line listing your entity type and **click** '**Notes**'. Computer browsers may display a notification about the file download in different


ways. For example, Microsoft Edge might display the file in the browser along with this message:



If needed, click the 'Download file' button. Then, *some* browsers will display a separate window with the file options: 'Open, Save, or Save As'. Others will display a message on a side panel, top-right corner, or bottom of the web page *similar* to these:



As seen in the image that follows, click the (1) ellipse (or an upward arrow ^) next to the message, and then from the menu select (2) Open



Upon opening it, *sometimes* the browser will display a message at the top or bottom of the screen similar to the one below:



Click the 'Enable Editing' button and then click the File menu. Click 'Save As' and browse to a file folder of your choice, such as the 'Documents' folder. As of the print date of the year end procedures, the file name for the township regulatory notes shell is:

'AOS_Regulatory_Basis_Township_Footnote_Shell_Dec2023.docx'

UAN recommends renaming the file name to something simple and unique to your entity, such as '2024 Example Township AFR Notes'.

If you are unsure of which notes to the annual financial statements are applicable for your entity type or have questions about the content of the note shells, please review all applicable information provided on the AOS website, and then if needed, contact Local Government Services at ContactLGS@ohioauditor.gov or 800-345-2519.


EXPORT AN EXCEL FILE THAT WILL HELP WITH NOTES PREPARATION

UAN Menu: General → Reports & Statements → Year End → AFR – Regulatory Statements, select 'Budgetary Notes Information Export' from the menu. Click Export and an Excel file will save to C:_UAN_Efiles. Use Windows File Explorer to browse and open the spreadsheet to review. It is designed to make it easier to incorporate budgetary disclosures into the Notes to the Annual Financial Statements.

STEPS TO SAVE MICROSOFT WORD FILES TO ADOBE PDF FORMAT:

Add-in documents are restricted to files formatted in Adobe PDF. The Auditor of State's Office requires this so that all add-in files will be a uniform file type. *Reminder: all 2024 add-in files will compress into one AOS submission file (the AFR-AOS Backup) when you close the fiscal year.*

The following steps explain how to save a Microsoft Word file to Adobe PDF format: Open the Word document. Click the 'File' menu and click 'Save As' and a 'Save As' window will open similar to the following example.



If needed, use the browsing pane on the left to navigate to a folder in which you would like to save the file (for example, Documents). Confirm or edit the 'File name' field. Click the 'Save as type' menu and select 'PDF'. Then click 'Save' and a PDF file version of your Word document will be saved there. Depending on the computer's Microsoft default options, it may or may not automatically open the PDF after processing. If not, press the Window's key and start typing 'File Explorer' and when it appears as a 'Best Match' list, click to open it. Browse to the location where you saved the file to view and confirm it saved correctly.

USING THE AFR – NOTES & DOCUMENTS AREA

UAN Menu: General → Reports & Statements → Year End → AFR – Notes & Documents

Confirm the 'Year' menu is set to 2024 (located to the right of the Add button). If not, click to change it to 2024 before continuing.

Add

- 1. Click 'Add' to open the 'Add AFR Document' form.
- 2. Click 'Browse' to open a Window's 'Open' form to pick the file.

 If necessary, use the shortcuts or Search option in the Window's 'Open' file form to navigate to the computer directory to the file location.
- 3. Select the file, and then click 'Open' to return to the 'Add AFR Document' form.
- 4. Click 'Save' in the 'Add AFR Document' form to save the file to the 'AFR Notes & Documents' list. UAN will include all files in the list when you process the next AOS submission by internet (or disc).

Delete

Use to delete documents added in error or that revised documents will replace.

Display

Display will open the selected PDF file.

IMPORTANT:

Make sure that you use the display button to verify that the correct information was added-in successfully to the AFR – Notes & Documents area.

- If you added the wrong file, then delete the file in the AFR Notes & Documents area. Use Window's File Explorer to identify the location of the correct PDF file. Return to the AFR Notes & Documents area in UAN and repeat the 'Add' steps to add the correct file.
- If the file needs to be revised, then delete the file in the AFR Notes & Documents area. Open the file in the application in which it was originally created (e.g. MS Word) and complete any necessary changes. Save the revised copy in the original application and then save it as a PDF file. Return to the AFR Notes & Documents area in UAN and repeat the 'Add' steps to add the updated file.

AFR - REGULATORY STATEMENTS

It is not necessary to send a paper copy of the AFR to the Auditor of State's Office. The entity's annual financial report information will be submitted as part of the 'AFR – AOS Backup' internet (or disc) submission when you close the year. However, entities should maintain one printed copy of the annual financial reports for public record purposes. UAN also recommends saving the reports as PDF files in case of public records requests.

UAN Menu: General → Reports & Statements → Year End → AFR – Regulatory Statements, select the year and then the statement name. By default, all amounts listed on AFR statements round to the nearest whole dollar as required by the Auditor of State's Office. If you would like to print the statements for internal use with amounts rounded to the nearest penny for precise comparison with non-AFR reports, click the "Options" tab and remove the checkmark ' \square Round to whole dollars'.

DECEMBER 31ST YEAR-TO-DATE REPORTS

Print reports that include a record of all entity activity from January 1 to December 31, 2024. Optionally, save each report as a PDF file. The AOS audit division recommends that entities retain year-to-date reports. Monthly reports are acceptable <u>only if</u> you have printed a final monthly report <u>each (and every) month</u>. Suggested reports are in the list below. Select the report from the drop-down menu and then 2024. Depending on the report, the date range must be set to either 'Year' or 'As of' 12/31/2024.

PAYROLL SPECIFIC YEAR END REPORTS

UAN does not provide a list of payroll reports to print at year end, although you may want to select some reports to Print or PDF for the year. The payroll reports you will have to present at your next audit include the forms W-2 and W-3, all monthly and/or quarterly tax and retirement reports you have filed, and the payments corresponding to these reports. You should have physical copies of these reports for your next audit. If you did not keep physical copies of the reports filed, gather that information now. Note that UAN will generate reports that indicate what you *should* have reported, but it may not reflect what you *actually* filed.

Often the December and/or 4th Quarter reports are forgotten in the busy rush of closing the year. Remember that you must file the December OPERS/OP&FPF Retirement reports after you have posted the final wages for pay periods ending in December. You must also file Federal, State, and Local tax reports for the month and/or quarter, **and** the 4th quarter ODJFS (Ohio Department of Job & Family Services) Wage Detail after you have posted all wages with December post dates. You must print the W-2 and W-3 forms, and submit them per IRS instructions to the employees and the Social Security Administration.

State, School, and Local taxes many times require you to file an annual report that compiles all wages and withholdings for the year to submit with or in addition to the forms W-2. It is your responsibility to contact these agencies to determine the forms you need and the deadlines to file. Reports you may want to print to complete these reports:

UAN Menu: Payroll → Reports & Statements → Tax Reports – Other (select Ohio Tax Report, School Tax Report, and/or Local Tax Report). Mark "Year", select all items, and Print.

1099 REQUIRED – FLAG VENDORS AHEAD OF TIME

You can flag the vendors in UAN to make it easier to select all vendors that the IRS requires you to send a 1099 form when the time comes each year. To put a vendor on the '1099 required' list, go to General → Maintenance → Vendors/Payees, checkmark the vendor and click Edit. In the Edit Vendor/Payee form mark it as '☑ 1099 Required'. To save the form you must include the vendor's Tax ID or Social Security Number from the IRS Form W-9. If you still need this from the vendor, mark '☑ W-9 Needed' as a reminder to contact the vendor for this information.

Many of the reports under General → Reports & Statements → Vendors/Payees, such as the Vendor/Payee Listing, will include this information so that you can review it throughout the year to be sure vendors are up-to-date.

Form 1099-NEC and Form 1099-MISC General Information

- The IRS has **not** authorized using UAN to print these forms on plain paper.
- Read the Version 2025.1 Overview about the **IRS E-Filing requirements** for 'information returns' such as these and W-2s to determine if it is required of your entity.
- Most likely *very few* UAN clients will need to process Form 1099-Misc, although <u>each fiscal officer should closely review the IRS requirements to make a determination.</u>
- As of 2022, neither IRS form includes a form year. Instead, the user must indicate the calendar year for which payments are being reported. Upon printing, UAN will fill in the year 'For calendar year 20' 'field based on your selection in each list's 'Year' menu.

NOTICE: By design, the Vendor / Payee 'Address Line 2' will not print on 1099-NEC Forms Beginning with the 2021 reporting year, the IRS announced a 1099-NEC formatting change from 2-part to 3-part forms (the 1099-Misc Forms continue to be 2-part forms). To accommodate the change, UAN developers stopped the vendor's location address 'Line 2' from copying into the 1099-NEC form. Line 2 is not widely used by UAN clients so most will be unaffected. You must confirm whether your entity has any vendors with essential 1099-NEC address information in Line 2 and then edit to include that information in Line 1.

REVIEW VENDORS REQUIRING A 1099-NEC FORM

Find out if any of your vendors requiring a 1099-NEC are affected. An easy way to do this is to export a spreadsheet version of the Vendor / Payee report called 'Export Vendor / Payee'

- General → Reports & Statements → Vendor / Payee Reports. Select 'Export Vendor / Payee' from the menu and select 2024.
- Select the 'Filters' tab and change the '1099 Required' menu from 'All' to 'Yes' to exclude all vendors that are not marked as '1099 Required' in their vendor settings.
- Select all vendors and click Export to create an Excel file. A Window's 'Save As' screen will open listing the file name 'Export Vendor Payee ...' and the file location it will be saved (the default will be C:\ UAN Efiles). Click Save.
- Use Windows File Explorer to open the 'Export Vendor Payee ...' Excel file. Find the 'Address Line 2' column and scroll the list to identify vendors with essential information (if any) for the 1099-NEC. Make a list of those you will need to edit.

Are any of your vendors affected?

If yes, UAN recommends editing the vendor's address in General \rightarrow Maintenance \rightarrow Vendors / Payees before you add the 2024 1099-NEC forms so that the change will affect all future forms and reports. Follow the steps on the next page.

Steps to edit a Vendor/Payee Location:

- 1. General \rightarrow Maintenance \rightarrow Vendors / Payees.
- 2. Checkmark a vendor and click Edit.
- 3. Checkmark a Location and click Edit.
- 4. Complete the address edits and then click Save and Close. (Repeat steps 3-4 if there are multiple Locations affected).
- 5. Click Close to return to the list of vendors. (Repeat steps 2-5 for all vendors affected.)

Tip: If you are comfortable using the navigation arrows at the bottom of each form (for example [1] of 6 [2] of 6 [2]), you can enter changes more efficiently than one vendor or location at a time by clicking the arrows to move to the next item selected.

Important: if you wait to enter the changes until *after closing the fiscal year 2024*, editing the vendor will not update the 2024 1099-NEC form even if you delete and add a new 1099-NEC form. In that case, you will need to edit the 2024's 1099-NEC form directly, as well as edit the vendor (steps above) for future reports and forms.


NOTICE: 1099 PRINT LAYOUT

UAN's standard layout for printing to Forms 1099-NEC & 1099-Misc corresponds to the IRS guidelines. Unfortunately, it has come to our attention that there are some 1099 Forms commonly available from print companies that do not exactly fit the IRS format – even some which are advertised as 'IRS certified' or 'IRS Approved'. This means the vendor name and other data could print in the wrong place on the form.

Given the above possibility, we recommend testing with one page of 1099 data to confirm that the standard layout of the 1099 Form in UAN corresponds to your IRS 1099 Form. If all fields print to the right places on the form, you can confidently print larger batches. Otherwise, if a problem is detected, UAN provides a means to customize the form layout so that you can still print to forms that have minor variations from the standard.

To customize the print layout of 1099-NEC, 1099-Misc, or 1096 go to:

UAN Menu: General → Maintenance → Entity Setup, select the 'Forms' tab. Choose 'Use custom layout under the applicable form heading. Then select the filing year and click the Design button to open the Form Designer window, as seen in the example below.



When you click on the Design button it will open a window where you can make adjustments to the layout. UAN provides a brief video to demonstrate using the design windows which are all very similar in function. View the video at https://uanlink.ohioauditor.gov as seen below:



1099-NEC & 1096 FORMS

UAN Menu: General → Reports & Statements → Year End → 1099-NEC & 1096 Forms. Upon opening, confirm or change the Year to 2024.

Add Click to add vendors to the list of those for whom you will print forms 1099-NEC. Read the message and click OK to open the Add form. If needed, filter the vendors by Vendor Type or Payment Total (see below). Then mark the checkboxes next to the vendors to include. Click Save to add them to the 1099-NEC & 1096 Forms list. **Note**: You may add only one 1099-NEC form per vendor, per selected year. Existing forms are available to edit or delete.

Vendor Type section

- All Vendors: Select this option to list ALL vendors, regardless of whether they are marked '1099 Required' on the Vendor/Payee form.

Payment Total section

- At Least: You can narrow down the list to show only vendors that have payments totaling at least \$[fill in an amount] that year.
- Any Amount: regardless of the payment amount, selecting this will display all vendors based only on your selection of 1099 Required or All Vendors.

Click 'Update Grid' to apply any changes to the Vendor list.

Edit Use to override any default vendor information relevant to the 1099-NEC form. Select the vendors and click Edit to view and override data when necessary.

Note: direct edits to the 1099-NEC form will not permanently update the vendor information in UAN. When you still have access to the older fiscal year, it is better to first delete the 1099-NEC, correct the source of the problem in UAN, then add the 1099-NEC form so it will include the new information. For example, if the address is incorrect, you would edit the Vendor/Payee form in General → Maintenance → Vendor/Payees. Another correction might involve posting an electronic payment that is missing in UAN. However, if you discover an error *after closing of the fiscal year*, the correction in other areas of UAN will not update by adding a new 1099-NEC form. In that case, you will need to edit the 1099-NEC form as well as correct the problem elsewhere.

1095 & 1094 FORMS

UAN Menu: Payroll → Reports & Statements → External Forms → 1095 & 1094 Forms to open the area. If needed, change the Year to 2024.

The majority of UAN clients may not be required by the IRS to complete the 1095 or 1094 forms, but it is very important that you determine any requirement for your particular entity and comply if necessary. UAN Support can ONLY provide technical software assistance for using the 1095 & 1094 area, but CANNOT provide instructions or advice on whether the form applies to your entity or the content entered on the form.

Per the IRS, only Applicable Large Employers (ALEs) and Self-Insured Coverage (SIC) providers must file 1095 and 1094 forms. ALEs are entities with 50 or more full-time employees – including *full-time-equivalent* (as determined by IRS guidelines) employees. A SIC provider healthcare plan is one in which the entity is responsible for paying the claims of the healthcare provided to the individuals enrolled in the plan. This **does not** include plans where the entity pays an insurance company the premiums for healthcare coverage and the insurance company is responsible for paying the claims of the individuals enrolled in the plan.

Again, UAN Support CANNOT determine if your entity fits these requirements. For guidance, call the Internal Revenue Service or visit www.irs.gov. You may find the following specific IRS web pages helpful. The first is a special IRS webpage set up to help employers comply with the Affordable Care Act reporting requirements https://www.irs.gov/Affordable-Care-Act/Employers

As you review the above IRS publications, consider the following questions:

- Is your entity an Applicable Large Employer (ALE)? If you are not sure, do you have 50 or more employees? If you do not have 50 or more employees, your entity is not ALE. If you have 50 or more employees, you will need to use the calculation provided on the IRS website to determine whether your entity is an ALE. The IRS calculation website is: https://www.irs.gov/Affordable-Care-Act/Employers/Determining-if-an-Employer-is-an-Applicable-Large-Employer
- Is the insurance your entity offers considered a self-insured plan? If so, does your entity offer Individual Coverage Health Reimbursement Arrangements (ICHRA) or a traditional HRA plan?

Skip the 1095 & 1094 forms **ONLY IF** you are confident that – based on the IRS guidance – the entity <u>is not</u> an ALE *and* <u>does not</u> offer insurance that the IRS considers a self-insured plan.

USING THE 1095 & 1094 FORMS AREA

Since it is likely that only a small number of UAN clients will be required to complete the 1095 & 1094 forms, we do not include the steps here. Instead, the instructions for each possibility are outlined in the UAN Payroll Manual, starting on page 111.

The IRS has authorized using UAN for printing these forms to plain paper, but also requires *most* entities (*among those required to complete these forms*) to file them electronically. Review the UAN Version 2025.1 Overview about the IRS E-Filing requirements for 'information returns' such as these and W-2 forms. Steps to create electronic files with UAN for IRS online filing, are now in the Payroll Manual, starting on page 126.

If needed, to view the instructions, go to:

UAN Menu: Payroll \rightarrow Reports & Statements \rightarrow External Forms \rightarrow 1095 & 1094 Forms to open the area. When open, click the FAQs menu link '1095 & 1094 Forms' in the lower-left corner of the screen.

944 FEDERAL ANNUAL TAX RETURN

UAN no longer produces the rarely used Form 944 Federal Annual Tax Return.

You must file annual Form 944 *instead of* filing quarterly Forms 941 <u>only if the IRS notified you in writing</u>. Form 944 is designed so the smallest employers will file and pay federal taxes only once a year instead of every quarter. For all questions about which forms your entity should file, contact the IRS or visit https://www.irs.gov.

Information for completing a 944 form is available on the 2 federal tax reports listed below* (using the "Year" date selection) in Payroll → Reports & Statements → Tax Reports – Federal. The "YTD Total" rows show the corresponding totals for the 944.

Everything else on the 944 form calculates from these figures. Total deposits for the year are available on the Vendor Payment Register: General \rightarrow Reports & Statements \rightarrow Vendor / Payee Reports (for the federal payee).

PREPARATION & REVIEW

VERIFY W-2 EMPLOYEE SETUP & WITHHOLDING INFORMATION

Edits to the following employee and withholding areas will not automatically update 2024 W-2 forms if done in the work year 2025 and more time-consuming manual edits will be necessary. Save time by verifying and entering any needed corrections *before closing the fiscal year 2024*.


Employee Information:

UAN Menu: Payroll → Maintenance → Employees, select all employees, click Edit and Advanced. On the Employee Information Tab, verify the name, address, and Social Security number. The most common changes are due to employees moving or name changes during the

year. Clicking Save after a change will advance the form to the next employee record. When no changes are necessary, use the navigation arrows in the bottom left corner of the form to advance to the next record e.g.

Local Tax W-2 Abbreviations and School District numbers:

UAN Menu: Payroll → Maintenance → Withholdings, select all Local and School tax withholdings, and click Edit. Verify that the W-2 Abbreviation is correct for all Local Taxes and that the School District # is correct for all school district income taxes.




RITA and / or CCA W-2 & W-3 Locality Tax Filing


If you do not have employees that report taxes for a municipality to the Regional Income Tax Agency (RITA) and/or the Central Collection Agency (CCA), then you may disregard the information that follows. UAN can now create an electronic W-2/W-3 file for these agencies provided that certain locality information is input into UAN's withholding settings for the local and school district taxes. (in rare situations, this may also include Miscellaneous withholdings for other state governments). Note: Except for RITA an CCA, UAN cannot create electronic files in place of W-2 Copy 1 forms for other local or city tax reporting.

Due to the nature of the requirements for each agency, the fiscal officer will need to obtain locality information from RITA and/or CCA to input into UAN before a file can be created. A tab page has been added to the withholding form for Local Tax withholdings in UAN for this purpose. Contact RITA for W-2 reporting requirements or CCA for their data format specifications and additional details.

 $UAN\ MENU$: Payroll \rightarrow Maintenance \rightarrow Withholdings. Select the local tax withheld and paid to either CCA or RITA and click Edit. Click the 'EFW2 Local Taxes' tab (1) and click the blue '?' icon (2) to open the information message, as seen in the following images:



The 'EFW2 Local Taxes' tab is available in the following withholding process groups highlighted in the following image:



RITA or CCA may require this information depending on whether the employee who reports taxes for a municipality to RITA or CCA also pays certain other government taxes including other Ohio local taxes, school districts taxes and other state income tax, local tax, county tax, etc. Contact RITA or CCA for guidance on their requirements.

Edits to the withholding EFW2 locality information will not automatically update 2024 W-2 data for use in the electronic file if they are done in the work year 2025 and more time-consuming manual edits will be necessary. Save time by verifying or entering any needed locality information *before closing the fiscal year 2024*.

CONFIRM ENTITY CONTACT AND TAX ID INFORMATION

Entity Information:

UAN Menu: General → Maintenance → Entity Setup. Verify or correct the Federal and State Tax IDs and the entity address listed. Unlike the Employee & Withholding information, you can edit

these fields *before or after* closing the fiscal year 2024. The information will be included, without manually editing, when printing each employee's W-2 form or when printing the W-3 form.

W-2 & W3 eFiles: Entity Setup edits will usually not update the corresponding electronic file fields if you will be creating W-2 & W-3 files for uploading to reporting agencies instead of mailing print copies. It may be necessary to update the information in both places. This is explained in more detail further along in the appendix.

ONLINE SUBMISSION REGISTRATION (WHEN APPLICABLE)

Newer fiscal officers may be unaware that the IRS applied a new electronic filing threshold for employers filing certain forms. This affects **almost all UAN clients** and applies when you have a *combined total* of 10 or more forms: W-2, W-3, 1099 NEC, 1099 Misc, 1094 and 1095. Each form's instructions include the details. <u>Note</u>: Your entity might have other IRS information returns that you complete outside of the UAN application that also count towards the threshold of ten.

In addition, the Ohio Department of Taxation (ODT) requires all employers who file and pay their employer withholding taxes electronically to upload their W-2 information electronically. And if you have employees that report taxes for a municipality to the Regional Income Tax Agency (RITA) and/or the Central Collection Agency (CCA), both have recently announced that they are applying the same IRS forms threshold (see above) for determining whether employers will be required to file W-2 forms electronically.

FIRST TIME E-FILERS:

If 2025 will be the first year that you will submit any of the above-mentioned IRS forms electronically for filing year 2024, then you need to make sure you **register well ahead of time** with the appropriate online system. New fiscal officers or those with any doubt of their status should **confirm** that they are properly registered. The registration deadlines for some of these online systems are fast approaching and processing wait time can be significantly long in some cases. **UAN Support urges you to review your status sooner rather later**. For more information, agency links and how to use UAN for this process, review page 88 and following.

TIMING: DETERMINING WHEN TO PRINT W-2 & W-3 FORMS

It is technically possible to add, edit and print 2024 W-2 forms regardless of the login work year or whether the fiscal year is closed i.e. you can complete these tasks while logged into either 2024 or 2025 and complete them either before or after closing 2024. However, to ensure accuracy, please review the recommendations below.

RECOMMENDED REVIEW PRIOR TO PROCESSING W-2 FORMS

Before printing W-2s, ensure that year-to-date tax reports balance with the totals that will report on the W-2 forms by completing the steps that follow. *Note*: the only entities that will be able to

produce accurate W-2 forms before closing the fiscal year 2024 are those that have no unresolved payroll issues and have a payroll schedule permitting the completion of the final wages, tax payments, and external withholding reports in December. Therefore, you may need to close the fiscal year before completing some of the steps below.

1) Research, identify, and resolve all 2024* unpaid withholdings and/or withholding overpayments that would affect the 2024 monthly/quarterly tax reports and W-2s.

*Unpaid withholdings and withholding overpayments carried forward **from years prior to** 2024 will not affect the 2024 W-2 forms but **will** affect your 2025 budget.

If there are any unresolved issues, UAN recommends reviewing the short video 'Evaluate Unpaid Withholdings'. Click or enter the link below and scroll to 'Housekeeping'.

- 2) Finish posting all 2024 Wages.
- 3) Prepare December and/or 4th Quarter tax reports.
- 4) Pay 2024 tax liabilities (either in 2024 or in 2025, if carried over).
- 5) Complete the December bank reconciliation it may reveal the need for correcting entries that could affect payments, external tax reports, and W-2s.
- 6) Make sure that the withholdings that will report on the W-2 forms will match those reported to the various withholding agencies when totaling the monthly or quarterly reports.


UAN Menu: Payroll \rightarrow Reports & Statements \rightarrow Tax Reports – Federal. Select the **W-2 Report**. Select all employees in the list and click Print.

The W-2 Report includes a 'Report Totals' section on the last page that includes the annual totals of the following taxes withheld (when applicable) from wages: **Federal Income Tax**, **Medicare**, **Social Security**, **Ohio Income Tax**, **School**, **and Local**. Investigate any discrepancies between the W-2 Report totals and actual amounts reported to the agencies.


Warning: UAN Payroll properly applies the laws that govern taxes and retirement to calculate the taxes for wages, generate the tax reports, payments, and W-2s. If, after a thorough examination, you find that you or someone prior to taking office have *manually edited tax-related withholdings* on wages (Payroll → Transactions → Wages, Edit) and/or have erroneously (over or under) corrected items *contrary to tax rates and laws* then UAN support staff cannot assist in determining how to amend your reports, payments, and/or W-2 forms. In such cases, you may need to consult a tax professional.

ADD W-2 FORMS

UAN Menu: Payroll \rightarrow Reports & Statements \rightarrow External Forms \rightarrow W-2 and W-3 Forms. Read the message and click OK. The W-2 & W-3 Forms tab will open to an empty list (unless employees were previously added). Please review the image below:



- 1. **Select the Report Year**. It is important to select the Report Year to the correct W-2 fiscal year *before clicking the Add button*. If you are working in the fiscal year 2024 the year 2024 will default in the box. If you are working in the fiscal year 2025, and you have posted wages in 2025, the year 2025 will default in the box. To select the correct fiscal year, click the Report Year menu.
- 2. Click Add and read the message:



As noted in the message, you *will* be able to manually edit W-2s or delete them to start over. However, the W-2 *report* will not reflect manual edits – it will continue to report the data from the actual payroll postings.

3. Click OK to continue. The Add W-2 Form opens and the upper left corner defaults to (active and inactive) employees "Paid This Year" for the fiscal year 2024 as seen in the screen that follows.



Special Note for entities that joined UAN in 2024: even if there are no posted wages in UAN it is still possible to use the software to create and edit W-2s – as long the employees have been added under Payroll \rightarrow Maintenance. If this is the case, select All Employees.

4. **Select employees** that you would like to add to the W-2 Forms list at this time and **click Save**. A confirmation message will appear in the lower-left corner of the form. **Click Close** and the list will update.


EDIT W-2 FORMS

Important Note: the W-2 report will not reflect manual edits to the W-2 forms – it will continue to report the data from the actual payroll postings. Only the W-2 forms and the corresponding W-3 forms will reflect the edits. When edits are necessary, UAN recommends verifying that 941 reports and state, local, and school tax report totals balance with the corresponding W-3 report before issuing W-2 forms to employees. The taxing districts will compare your W-2 forms with the reports filed and payments made for 2024. If there is a discrepancy, they will require you to reconcile the items; therefore, UAN recommends that you reconcile and correct any errors before issuing the W-2 forms.

Steps to Edit W-2 forms:

After employee data has been added to the list, W-2 forms can be edited when necessary.


1. Select the employee name and click Edit. A message will open:



- 2. **Read and click OK.** Note: the message is explained in greater detail later in this booklet. The Edit W-2 Form will open as seen in the illustrated screen that follows.
- 3. **Edit** only when absolutely necessary. In most circumstances when Payroll maintenance and transactions have been entered correctly throughout the year there is no need to edit the W-2. Review the Edit W-2 Form Guide that follows a detailed explanation of form options.
- 4. Click Save after all edits are complete. If multiple employees were selected, the form will advance to the next employee. After all the employees selected are complete, click Close.

Edit W-2 Form Guide:

Review the illustrated screen that follows to familiarize yourself with the form layout.




First, double-check the Employer's address and Federal Tax ID in the bottom center of the form. As previously mentioned, the Employer information listed cannot be edited on the form itself. If any employer information is incorrect, review the instructions under the 'Confirm entity contact and tax ID information' notes starting on page 74 and then edit the W-2.

All **employee-specific** contact information can be overridden on the Edit W-2 Form *only after the fiscal year 2024 is closed*. Ideally, it is better to discover discrepancies before closing the fiscal year 2024 by completing the steps in 'Preparation & Review' (starting on page 72) so that you only have to enter updates one time – at the source – under Payroll → Maintenance → Employees.

The Edit W-2 Form is designed so that you can change employee information that will print on the W-2 while still being able to view the latest data that was created (calculated or saved) in the fiscal year 2024. The form is separated into sections and tabbed pages. Notice the employee sections in view when the form is first opened: Name, Details, Box 13, and Federal under the Federal tab. Each section includes either a 'Saved' or 'Calculated' area and an Override button that will enable edits. To make changes in any section, select the corresponding Override button and edit the items you wish to change in the override area; the original data cannot be changed, but when the Override button is selected, only the data in the override area will print on the W-2. All sections that do not have Override selected will print the latest data that was created (calculated or saved) in the fiscal year 2024.

For example, in the screen that follows, notice that the Federal section defaults to 'Print Federal Calculated', but it can be changed to 'Print Federal Override'. Selecting the 'Print Federal Override' button will duplicate the amounts listed in the 'Print Federal Calculated' column. Type over any amounts in the override column that need to change and those amounts will be printed on the W-2 instead of the calculated amounts.




The State & Box 12 tab and the Local & Box 14 tab include sections for the UAN calculated data and areas to override that data *when necessary*. Review the illustrated screens that follow.

Local & Box 14 Tab is selected on this screen.



When selecting Override, the original data is duplicated into the override area. You can **edit** the existing override lines, **delete** lines by clicking an X next to the row or use a data entry line to **add** new lines. Clicking Save will advance the screen to the next employee. Continue until you have

completed reviewing and (when necessary) editing other W-2s. Click Close to exit the form. Keep the W-2 & W-3 Forms area open when you are ready to print.

W-2 EDITOR

The W-2 Editor is an optional tool for quickly adding or editing data in W-2 boxes 12, 13, and 14 for multiple employees at a time. Instructions are included in the UAN Payroll Manual. To access the W-2 Editor instructions go to Payroll \rightarrow Reports & Statements \rightarrow External Forms \rightarrow W-2 and W-3 Forms. Read the message and click OK. In the bottom left corner, *under the FAQs menu*, click the 'W-2 Editor' link and the manual will open to the instructions.

PRINT W-2 FORMS OVERVIEW

UAN will ONLY print W-2 & W-3 forms on plain blank paper. When printed from UAN, the forms meet the Social Security Administration's (SSA) 2024 plain paper requirements. In addition to saving money, plain paper printing prevents various printer alignment issues that are often encountered with pre-printed forms.

Optional: *perforated* plain blank paper purchased from third-party vendors may be used. The styles compliant with UAN software are the 2-Part (2-up) sheets with one horizontal perforation (2 per sheet), and the 4-Part (4-up) sheets with three horizontal perforations (4 per sheet).

UAN Menu: Payroll \rightarrow Reports & Statements \rightarrow External Forms \rightarrow W-2 and W-3 Forms. Read the message and click OK. Select 2024 from the Report Year menu. Select all of the employees from the list and click the Print W-2 button and the Print W-2 Form will open.

Form Options:

- W-2 Copy buttons: select to print *one copy type at a time* i.e. print one set of W-2 copies for the selected group of employees before moving on to the next set of W-2 copies.
- There is no required order for printing the W-2 copy types. For example, all Copy D forms could be printed before printing Copy A forms or visa vera.
- Order by: Name or SSN: At the bottom of the form, you may select to sort the W-2 copies by employee name or by social security number. You do not have to use the same setting for all W-2 copy types.
- <u>Important</u>: blank paper printing of W-2 forms requires printing a separate 'Notice to Employee' page to include with each employee W-2 form. Instructions start on page 85.
- For any employees whose withholding information cannot fit onto a single W-2, extra copies will print automatically (omitting certain redundant information, as specified by the form instructions).

Copy A – Social Security Administration (SSA) Requirements:

- <u>SSA Electronic filing options</u>: Entities that have registered with the SSA to upload an electronic W-2 and W-3 file do not need to print the Employer Copy A: Federal (SSA).
 - o Instructions to create the electronic file start on page 88.
- <u>SSA Paper Reporting Requirements</u>: the SSA requires that Copy A of the forms W-2 (and the W-3) be separated into MQGE and 941/944 batches for paper reporting.
 - o MQGE employees are defined as those with Medicare + OPERS / OP&FPF deductions and 941 / 944 employees as everyone else.
 - o The software will automatically print Copy A in separate batches.
 - o Be prepared to pair each W-3 with its corresponding W-2 batch for mailing.

Copy 1: State / City / Local – Special Considerations:

Employers may be required to submit Copy 1 for State Tax withholdings and (when applicable) any withholdings for school tax or local tax agencies. A separate Copy 1 must be printed to submit to each tax district as required by those agencies. Entities that are required to file a monthly or quarterly report for school or local taxes will also be required to submit an annual reporting form along with Copy 1. UAN staff cannot provide any further guidance on specific tax district filing requirements – contact the tax district for instructions and obtain their annual forms.

PRINT W-2 FORMS

Important: Read the Print W-2 Forms Overview (if you have not already) before continuing.

Time-Saving Tip: if possible, print all W-2 Copy sets before exiting the Print W-2 form.

Explanation: the first group of W-2 forms sent to the printer takes longer because it triggers a temporary calculation that will be used for all W-2 copies that will be printed while the Print W-2 form is open. If the Print W-2 form is closed and reopened, the software will have to repeat the temporary calculation when the next group is selected for printing.

Printing Instructions for W-2 Forms – Copy B, C, D, and Copy 2:

- 1. Select a W-2 Form Copy type to print.
- 2. Confirm or change the sort 'Order by' button selected i.e. order employees by name or SSN.
- 3. Verify that you have the correct paper in the printer tray.
- 4. Click OK and then click Print when the printer message opens.
- 5. Repeat the steps above until all needed Employee and Employer sets print for these copy types.

Printing Instructions for W-2 Forms – Copy A:

- 1. Select W-2 Form Copy A type to print.
- 2. Confirm or change the sort 'Order by' button selected i.e. order employees by name or SSN.
- 3. Verify that you have the correct paper in the printer tray.
- 4. Click OK to print.

The steps that follow (a. or b.) will depend on the group of employees selected:

- a. When the employees selected <u>include</u> **only one type** (MQGE **or** 941/944), then the software will automatically send the W-2 forms in one batch to be printed.
 - i. Click Print when the printer message opens.
- b. When the employees selected include **both types** (MQGE **and** 941/944), then the software will automatically print the W-2 forms in two separate batches.
 - i. Read the first message (also explained in the Print W-2 Forms Overview) and click OK and a second message will open.
 - ii. Read the second message and decide 'Should UAN pause printing between each group of Copy A forms?' Decide and click Yes or No.
 - If No was selected, UAN will print both groups without pausing.
 - o Click Print when the printer message opens.
 - If Yes was selected, then you will have to click OK to resume printing after the first group prints.
 - Click Print when the printer message opens. The first group of Copy A forms will print and a message will appear.
 - o After you remove and set aside the first group of Copy A forms, click OK to print the second group of Copy A forms.


Printing Instructions for W-2 Forms – Copy 1:

- 1. Select a W-2 Form Copy 1 type to print (2-part or 4-part employer). A vendor list menu will open below the button. It will only include options for the state, school, and local tax agencies that apply to the group of employees selected for printing.
- 2. Select one tax agency from the menu.
- 3. Confirm or change the sort 'Order by' button selected i.e. order employees by name or SSN.
- 4. Verify that you have the correct paper in the printer tray.
- 5. Click OK and then click Print when the printer message opens.
- 6. Repeat the steps above to print Copy 1 forms for each tax district as required by those agencies.

PRINT THE REQUIRED 'NOTICE TO EMPLOYEE'

All W-2s issued on blank paper must be accompanied by a Notice to Employee. You can print the Notice to Employee from the W-2 & W-3 Forms page.


UAN Menu: Payroll → Reports & Statements → External Forms → W-2 and W-3 Forms, the W-2 & W-3 Forms tab will open. Read the message and click OK. Select 2024 from the Report Year menu. Click the Print Notice button (*as seen below*) and the Print form will open. On the Print form, select the number of copies you need, and click Print.



PROCESSING W-3 FORMS

PRINT W-3 FORMS

UAN Menu: Payroll \rightarrow Reports & Statements \rightarrow External Forms \rightarrow W-2 and W-3 Forms. Read the message and click OK. Make sure 2024 is in the Report Year box. Select all of the employees from the list and click the Print W-3 button. A message will open:



Read the message and click OK. The Print W-3 form will open. Most of the information on the W-3 form is automatically generated based on the W-2 totals of the employees selected and therefore cannot be directly edited on the W-3. The exceptions include the list of items that follow. Note: the UAN default (amount or setting) of the items listed should be carefully reviewed and changed when necessary.

- 1) Kind of Employer: State/local non-501c or State/local 501c.

 The setting is located at the top-left of the form. Select the type applicable to your entity. Click the blue question mark ? for more information. If necessary, contact the IRS for assistance; UAN staff cannot answer questions about the selection.
- 2) Employer Information, Federal Tax ID & State Tax ID: confirm accuracy. The data on this form is copied from the application's Entity Setup. For filing purposes, you can edit any of the employer fields on the 'Print W-3' form except the tax IDs. In some cases, you might require different data on the 'Print W-3' form than what is in Entity Setup e.g. perhaps a different contact name or email. However, if the Entity Setup information is out of date, then go to General → Maintenance → Entity Setup to edit that first. If needed, you can edit the Federal & State tax IDs as well. Save, close, and then return to the 'Print W-3' form which will now include the corrections.
- 3) **Kind of Payer** federal tax report type: 941 Quarterly or 944 Annual (if available). The setting is located at the top-right of the form. Select the type applicable to your entity.
- 4) Total number of forms W-2 (Override) *only use if necessary*.


In the first row in the table, the total number of W-2 forms for the W-3 will automatically calculate. Some employees may generate more than one W-2 Form. Only edit this field when necessary.

5) Box 14: Income tax withheld by payer of third-party sick leave – when applicable. If the entity has income tax withheld by a payer of third-party sick pay, enter the total in this field. UAN staff cannot answer questions about third-party sick pay.


Note: the line for 'Local wages' is the total of all Local wages lines from the included W-2s. This ties the forms together. For example, if an employee earned \$10,000 subject to school tax and a village tax, the W-3 Local wages line sums it to \$20,000.

After confirming all items on the form are accurate, click OK to print.

When the selected employees include both types (MQGE and 941/944 types), then the software will open the message that follows. Otherwise, it will skip to a print form.



When applicable, read the message and click OK to continue. A print form will open. Select the printer and click Print. The following message will open while the W-3 form(s) print:



Read the message. **Important**: this is something that <u>only you</u> can confirm. The tax districts will use your year-to-date tax deposits and/or reports to compare the W-2 forms for accuracy. This final review is especially important when you have edited wages, withholdings, or other items on

any W-2 form. Make sure the W-3 generated by the W-2 forms balance with year-to-date tax report totals. If they do not balance with the reports and taxes that have been paid then the respective tax agencies will contact you for an explanation of the discrepancy. Click OK to close the message.

CREATE W-2 & W-3 ELECTRONIC FILES (IF REQUIRED OR PREFERRED)

Recommendation: print the applicable W-2 & W-3 forms for in-office use even though it is not necessary for the SSA or the Ohio Department of Taxation when an electronic file is used. Complete the electronic file steps only after you have verified the accuracy of the printed forms.

UAN can create the following electronic files for submission:

- Social Security Administration (SSA): W-2 & W-3 Federal Tax Filing: Create a file containing W-2 & W-3 data that you can upload through the SSA website for the entity's federal tax filing i.e., in place of mailing W-2 Copy A and W-3 forms to the SSA. The entity must first register for electronic file upload with the Social Security Administration (SSA) before you can use this feature in UAN. Review the SSA webpage:

 https://www.ssa.gov/employer/ This webpage is current as of the Year End Procedures print date. Note: UAN Staff cannot assist with the registration.
- Ohio Department of Taxation: W-2 Ohio & School District Tax Filing. Create a file containing W-2 data for submission of Ohio and (if applicable) school district tax reporting i.e. in place of mailing W-2 Copy 1 forms. The Ohio Department of Taxation (ODT) requires that all employers who file and pay their employer withholding taxes electronically must also upload their W-2 information electronically through the Ohio Business Gateway.
 - Read more about the requirement and open ODT instructions from their 'W-2 /1099 Information Page.'

 - This webpage is current as of the Year End Procedures print date.
 - Scroll to section 'EFW2 (Specifications for Filing W-2 Forms Electronically)'
 - Click '2024 EFW2 Upload Specifications' and page 4 provides submission steps.
 - UAN staff can only answer questions applicable to creating and saving the data file to the UAN computer hard drive (instructions follow). The UAN steps will create the file in the EFW2 format that ODT requires. Please contact the Ohio Department of Taxation regarding all other questions about their online submissions.

Special Note for entities with school tax withholdings: school tax withholdings must be set up using the proper UAN processing group code to be included in the Ohio + Schools W-2 upload file. Before proceeding, verify that all relevant school taxes are set up as process group "G00 – School Tax" in Payroll \rightarrow Maintenance \rightarrow Withholdings (under the Process Group column). If

any school withholdings were set to an incorrect process group, contact UAN Support for assistance to correct the problem before creating the Ohio + Schools upload file.

• RITA and / or CCA W-2 & W-3 Locality Tax Filing

If you do not have employees that report taxes for a municipality to the Regional Income Tax Agency (RITA) and/or the Central Collection Agency (CCA), then you may disregard the information that follows. UAN can now create an electronic W-2/W-3 file for these agencies provided that certain locality information is input into UAN's withholding settings.

As noted above, in the **Preparation & Review** starting on 72, Edits to the withholding EFW2 locality information will not automatically update 2024 W-2 data for use in the electronic file if they are done in the work year 2025 and more time-consuming manual edits will be necessary. Save time by verifying or entering any needed locality information *before closing* the fiscal year 2024.


If you have already closed the fiscal year 2024 without updating necessary locality information, then follow the steps now to update the withholdings in **Preparation & Review** starting on 72 and then contact UAN to discuss additional steps necessary to edit W-2 forms before creating the electronic file.

Note: Except for RITA an CCA, UAN **cannot** create electronic files in place of W-2 Copy 1 forms for other local or city tax reporting.

STEPS TO CREATING W-2 / W-3 ELECTRONIC FILES

UAN MENU: Payroll → Reports & Statements → External Forms → W-2 and W-3 Forms, the
 W-2 & W-3 Forms tab will open. Select Report Year 2024. Select all of the employees in the list and click File.

You will receive the following message:



Read the message and **click OK**. The File W-2 and W-3 form opens.

Most of the information on the File W-2 and W-3 form is automatically generated based on the W-2 totals of the employees selected and therefore cannot be directly edited in this form. The exceptions include the list of items that follow. Note: the UAN default (amount or setting) of the items listed below should be carefully reviewed and changed when necessary.


- 1) Kind of Employer: State/local non-501c or State/local 501c.
 - The setting is located at the top-left of the form. Select the type applicable to your entity. Click the blue question mark ? for more information. If necessary, contact the IRS for assistance; UAN staff cannot answer questions about the selection.
- 2) **BSO** User ID: Enter the BSO (Business Services Online) User ID assigned by the Social Security Administration. The entity must be registered with the SSA to file electronically. Contact the SSA with questions about this.
 - ☐ **Resubmit WFID** (Wage File Identifier): Leave this checkbox unmarked for the initial submission. In a situation where you need to resubmit, you will need to enter a WFID supplied by the Social Security Administration. UAN cannot provide this information.
- 3) Federal Tax ID & State Tax ID: confirm accuracy. To correct tax IDs, cancel the form and go to General → Maintenance → Entity Setup to edit. Save, close, and then return to the 'File W-2 and W-3' form which will now include the corrections.
- 4) Employer Information: confirm accuracy. For filing purposes, you can edit any of the employer fields here besides the tax IDs. In some cases, you might require different data in the file than what is in your Entity Setup form e.g. perhaps a different contact name or email. However, if your Entity Setup form is out of date, then go to General → Maintenance → Entity Setup to edit that first. Save, close, and return to this form. The file fields will automatically update only if point (a) below applies to you:
 - a. **Customers new to W-2 e-filing**: If this will be your entity's *first time ever* creating a W-2 file, then updating the Entity Setup form will also update this form.
 - b. The majority of UAN customers: You may need to edit some of the information here, even if it is currently up to date in the Entity Setup form. Since most customers have created W-2 files in the past, UAN will default to the Employee Information entered when the first file was created (even if that was years ago). This inconvenience, in brief, is caused by some field restrictions the IRS has for the file that UAN does not restrict in our Entity Setup form.
- 5) **Kind of Payer** federal tax report type: 941 Quarterly or 944 Annual (if available). The setting is located at the top-right of the form. Select the type applicable to your entity.
- 6) **Box 14: Income tax withheld by payer of third-party sick leave** *when applicable*. If the entity has income tax withheld by a payer of third-party sick pay, enter the total in this field. UAN staff cannot answer questions about third-party sick pay.

Note: the line for 'Local wages' is the total of all Local wages lines from the included W-2s. This ties the forms together. For example, if an employee earned \$10,000 subject to school tax and a village tax, the W-3 Local wages line sums it to \$20,000.

After completing the form, select the 'Federal (SSA)' from the menu:

After confirming that the 'W2 SSA Upload 2024' and 'W2 Ohio Upload 2024' files transmit successfully, delete them under C:_UAN_EFiles and then empty them from your computer's Recycle Bin. Repeat these steps of you will be creating files for RITA and / or CCA.

Important: the W-2 files contain sensitive employee data in which there can be no encryption and therefore the information is not secure in cases of unauthorized computer access, virus, or malware infection. UAN is initially set up to delete these files automatically after a set number of hours in the event you accidentally leave one undeleted. You can confirm this setting under General → Maintenance → Entity Setup and click the System tab. For more information, click the ② icon in the 'Sensitive Unsecured UAN Efiles' section of the form.


SPECIAL NOTE FOR CLIENTS THAT CONVERTED TO UAN PAYROLL MID-YEAR 2024

Entities that began using UAN Payroll during the fiscal year 2024 had multiple choices to convert their previously posted 2024 payroll data into UAN. Before the close of 2024, you still have time to add employees and post conversion wages to bring your prior payroll ledger balance into UAN for W-2 printing. Review the following items to determine how to prepare for the 2024 W-2s:

- If you added all employees that were paid in the fiscal year 2024 and posted all the conversion wages to bring the year-to-date ledger balance into Payroll, you can print forms W-2 and W-3 as normal.
- If you added all of your 2024 employees to Payroll and began posting wages, but did not post a conversion wage you have the following three options:
 - A. **Prior to closing 2024,** you can post conversion wages to bring your prior payroll ledger balance into UAN, and then print the forms W-2 and W-3 as normal.
 - B. Add a W-2 for the employees and edit the figures to report the combined total of the wages paid from your prior payroll ledger and the UAN posted Payroll, and then print the forms W-2 and W-3 as normal.
 - C. Manually prepare your forms W-2 and W-3, combining the UAN posted payroll data and old payroll ledger balance.
- If you did not add all of your 2024 paid employees into Payroll and post conversion wages for them before the fiscal year 2024 is closed:
 - o Manually prepare your forms W-2 and W-3, combining the UAN posted payroll data and old payroll ledger balance.
- If you added all of your employees to UAN Payroll but did not post a conversion wage or any live wages in the software, then before the fiscal year 2024 is closed:
 - Post conversion wages for all employees from your payroll ledger and print the W-2 and W-3 reports. OR
 - o Manually prepare your forms W-2 and W-3 (i.e. outside of the UAN Payroll).
- Note: The W-3 form will compile the data from the selected W-2s in the software, including any edits you have made to the W-2s, but the W-3 cannot be edited to include any manually prepared W-2s.

APPENDIX 4: NEW YEAR ACCOUNTING PROCEDURES

When you open Temporary Mode in the calendar year 2024 you will be able to log into the work year 2025. During Temporary Mode, you may select the work year upon login. See below:



Although you will be able to log into the work year 2025 to begin your new year accounting procedures, you must pay particular attention to the effective date of the changes. The lists below contain brief instructions on how to complete the steps. For detailed information, follow the UAN Menu listed to open a particular area, and then click 'Need Help?' on the main menu for screen-specific information. Also, some areas include links to helpful screencast video tutorials located under the FAQs menu in the lower-left corner of the UAN screen.

REMOVE OR DEACTIVATE ITEMS NO LONGER NEEDED

The beginning of the year can be a good time to 'clean house' in the software to easily remove or deactivate items that will not be needed in the future. Some items may not be removable, but you can deactivate them. For example, you cannot remove appropriation accounts used on carryover purchase orders even though they will not be necessary for future activity after you post the final payment in the new year. If desired, you can deactivate them so that they will not display in transaction menus and certain reports. Deactivating an item will not affect transactions posted *prior* to deactivating. For example, deactivating an account used on a carryover purchase order will not prohibit you from making a payment using that purchase order, but *will* prevent you from selecting that account when creating a *new* purchase order.

Recommendation: Using filters in the areas below can save time. In the maintenance areas, click the 'Status' menu. In the reports areas, click the 'Filters' tab.

Remove or deactivate funds, revenue, and appropriation accounts

When the year is closed, the revenue and appropriation budgets are set to zero while the revenue and appropriation accounts carry to the new year. Note: the order below is important because you cannot remove funds until after removing all revenue and appropriation accounts in that fund.

APPENDIX 5: NEW YEAR PAYROLL PROCEDURES

When you open Temporary Mode in the calendar year 2024 you will be able to log into the work year 2025. Temporary Mode allows you to work in both fiscal years 2024 and 2025 before closing the fiscal year 2024, which provides many potential advantages. Opening Temporary Mode is a required step in the year end process, but working in 2025 before closing 2024 is completely optional. During Temporary Mode, you may select the work year upon login. See below:



Although you will be able to log into the work year 2025 to begin your new year payroll procedures, you must pay particular attention to the effective date of the changes.

For example, local and school tax rates become effective on January 1. Therefore, a new withholding for the local or school tax must be added and then added to each employee before the first wages are posted in the new year. A change to the rate of an existing local or school tax must be edited to the new rate and the employees updated (*using the Withholding Editor*) before the first wages are posted in the new year.

Likewise, you may have employees that receive pay increases or leave balance adjustments that take effect on January 1. Before you update the employees in the work year 2025 make sure you will be posting a pay period that includes the effective date of these local policy items. Review the last section of this appendix for important considerations before completing leave adjustments.

The following pages contain brief instructions about each subject. For detailed information, follow the UAN Menu provided to open the form or list and then click 'Need Help?' on the main menu for screen-specific information. Also, some areas include links to helpful screencast video tutorials located under the FAQs menu in the lower-left corner of the UAN screen.

- Click the Appropriations Accounts (Fringe Benefits) tab if applicable. Confirm the split method and the appropriation accounts that will pay the fringe benefit.
- Optional: click the Skip Deductions tab (*only available for certain withholding types*). Review the settings or read the on-screen instructions to complete the form. Note: the blue question mark ② on this tab provides additional instructions about completing the tab correctly.
- Click Save and Close

Withholdings - Add New

- Click the Withholdings tab and click Add and a withholding form opens.
- Do not click save until you have completed all steps in the order below:
 - Select a withholding from the menu and confirm or revise the description.
 Note: you cannot have two withholdings with the same description.
 - O Details tab review or change the default rate or amount. If the withholding has an employer share distribution, review the applicable rates.
 - Click the Earnings tab to ☑ checkmark the earnings in which the withholding should be deducted when the earning (or attached items such as overtime) is paid.
 - o If this withholding has an Employer Share Click on the Appropriations Accounts (Employer Share) tab and select the split method and appropriation accounts that will pay the employer share
 - If this is a withholding that has a fringe benefit option, click on the Fringe Benefits tab and select the split method and appropriation accounts that will pay the fringe benefit.

Payroll → Maintenance → Employees Checkmark Employee, Click Edit - Advanced

- Optional: click the Skip Deductions tab (*only available for certain withholding types*). Read the on-screen instructions to complete the form. Note: the blue question mark ? on this tab provides additional instructions about completing the tab correctly.
- Click Save and Close

This is a very convenient option when an employee withholding for multiple employees should be set to skip (not be deducted on) certain pay periods. To review a detailed description, click the 'Overview' link under the FAQs menu when this area is open.

Reminder: Only employee withholdings that are set to skip deductions under Payroll \rightarrow Maintenance \rightarrow Employees will be available to apply a skip calendar and additional employee-specific maintenance items may need to be updated before adding/applying skip calendars.

Withholdings – Deactivate

- Click the Withholdings tab and mark an item in the list.
- Click Deactivate below the list. Then click Save and Close.

EVALUATE LEAVE BALANCES

<u>Caution!</u> Leave balance adjustments in Temporary Mode: UAN recommends you post all final wages in the work year 2024 before making any leave balance adjustments in the work year 2025. Wages posted in 2024 may impact the amount you should adjust in 2025, so wait until all 2024 wages are posted before adjusting leave for the new year as required by your policy.

If you need to adjust leave balances in the new year, pay particular attention to the date you are paying wages, the pay period of the wages, and the date the leave changes are effective pursuant to your policy, and then adjust them at the proper time. *UAN Menu*: Payroll \rightarrow Utilities \rightarrow Leave Balance Adjustment. You will receive a message advising that you should retain supporting documentation for all leave balance adjustments; Audit will closely scrutinize them. Click OK.

On the Post Leave Balance Adjustment Form, you can select adjust *By Employee* to adjust one employee at a time or select *By Leave* to adjust all employees with the same leave at once. Make adjustments as positive or negative numbers in the adjustment column. Enter the reason for the adjustment (e.g. 2025 Leave Granted; 2024 Unused leave lost per policy, etc.). Enter the effective date of the leave adjustment and click Post. You can print leave reports to verify correct balances: *UAN Menu*: Payroll \rightarrow Reports & Statements \rightarrow Leave Reports, select the desired report from the form menu, select the employees, and then click Print.

APPENDIX 6: YEAR END BALANCES CERTIFICATES

UAN provides a template for the 'Certificate Of The Total Amount From All Sources Available For Expenditures, And Balances', also referred to as the Year End Balances Certificate. The area for creating this is located in the Budget module:

UAN Menu: Budget → Transactions → Year End Balances Certificates

IMPORTANT: You should add the year end certificate *only after* posting *ALL* fiscal year 2024 transactions, utility adjustments, and the 12/31/2024 bank reconciliation. To add a year end balances certificate with balances as of 12/31/2024, log into UAN either by selecting Work Year © 2025 when Temporary Mode is open *OR* in 2025 after the fiscal year 2024 is closed. Go to Budget →Transactions →Year End Balances Certificates and confirm the default year - 2025 - is selected from the Year menu. Then click the Add button to open an Add Year End Balances Certificates form with "Balances as of 12/31/2024".

Note: If you attempt to add the certificate while working in the fiscal year 2024 (with 2024 selected in the Year menu) the Add Year End Balances Certificates form will open, but it will pull in "Balances as of 12/31/2023".

ADD

You must specify a certificate name when adding a year end balances certificate. All funds from the current and prior year display and all amounts are available to edit.

The Add form has two tabs: The Funds tab shows all funds and allows for edits to the data. The Display-Summary tab is read-only; displaying the data (*including edits*) from the Funds tab. The Display-Summary tab shows totals summed by fund type (*General, Special Revenue...etc.*) with totals for Governmental, Proprietary, and Fiduciary funds and a total for all funds.

EDIT

When there are edits to a certificate, any amounts saved to the worksheet that differs from the amounts calculated by UAN will list in a popup form 'Update Year End Balances'. Optionally, any of the differing amounts on the certificate can be automatically updated to the amount calculated by UAN by selecting the amount on the pop-up form to import. (See the Edit and Delete restrictions notes below).

DELETE

Use to delete year end balances certificates. (See Edit and Delete restrictions note below).

Edit and Delete Restrictions For Prior Years

Year end certificates that may have been added in previous years cannot be edited or deleted after closing the fiscal year. For example, any 2023 year end balances certificate that were added by the user while logged into 2024 (*whether before or after opening Temporary Mode*) will be unavailable to edit or delete after closing the fiscal year 2024.

PRINT / DISPLAY / SAVE PDF

A summary page will be produced along with a listing of all the funds on the certificate.

PRINT BLANK – located next to the add button

If needed, a blank copy of the certificate may be printed.

EXPLANATIONS OF COLUMN HEADINGS - YEAR END BALANCE CERT.

Note: The following information assumes a year end balances certificate is being added for balances as of 12/31/2024 while logged into UAN either by selecting Work Year \odot 2025 when Temporary Mode is open OR in 2025 after the fiscal year 2024 is closed.

1. Cash Balances as of 12/31/2024

Definition: Cash balances per the cashbook of the governmental entity as of December 31.

Location in UAN: Prior year report, as of 12/31/2024

The 'Fund Balance as of 12/31/2024' on the Cash Summary by Fund. Menu path: Accounting → Reports and Statements → Fund Reports, select Cash Summary by Fund and select 2024 from the Year menu.

2. Reserved for Encumbrance as of 12/31/2024

Definition: All outstanding unliquidated encumbrances as of December 31, obligations in the form of purchase orders or contracts which were charged to a prior year's appropriation and for which a part of that appropriation is reserved (carryover purchase orders and withholdings).

Location in UAN: Prior year report, as of 12/31/2024

The 'Current Reserve for Encumbrance' on the Fund Summary. Menu path: Accounting → Reports and Statements → Management Reports, select Fund Summary, and select 2024 from the Year menu.

3. Reserved for Non-Spendable Balance as of 12/31/2024

Definition: Reserve for funds that require non-expendable balances such as permanent funds and some private purpose trust funds. The non-expendable balances are set in Accounting → Maintenance → Funds.

Location in UAN: Prior year report, as of 12/31/2024

The 'Reserved for Non-Spendable Balance 12/31' column on the Resources Available for Appropriation. Menu path: Accounting → Reports and Statements → Budgetary Reports, select Resources Available for Appropriation and 2024 from the Year menu.

4. Reserve Balance Accounts

Definition: Reserve Balance Accounts as per sections 5705.13(A)(1) and/or 5705.132 of the Ohio Revised Code (ORC).

Location in UAN: Prior year report, as of 12/31/2024

The 'Reserve Balance (5705.13(A)(1) & 5705.132) 12/31' column on the Resources Available for Appropriation. Menu path: Accounting \rightarrow Reports and Statements \rightarrow Budgetary Reports, select Resources Available for Appropriation and 2024 from the Year menu.

5. Advances Not Repaid

Definition: Advances not repaid as of December 31---this amount should be added to the fund that made the advance and subtracted from the fund that will be making the reimbursement.

Location in UAN: *Current year* report, as of 1/1/2025

The 'Prior Year Advances Not Repaid 12/31' column on the Resources Available for Appropriation. Menu path: Accounting → Reports and Statements → Budgetary Reports, select Resources Available for Appropriation and 2025 from the Year menu.

6. Carryover Balances Available for Appropriations

Calculation: Columns 1 - 2 - 3 - 4 + 5 = Column 6

Cash Balance 12/31 (column #1) minus Reserved for Encumbrance 12/31 (column #2) minus Reserved for Non-Spendable Balance 12/31 (column #3) minus Reserve Balance Accounts (column #4) plus Advances not Repaid (column #5)

7. Total Amount from All Sources Available for Expenditures

Definition: The total amount from all sources the governmental unit expects to receive during the forthcoming fiscal year, which is available for expenditures.

Location in UAN: *Current year* report, as of 1/1/2025

Accounting → Reports & Statements → Revenue Reports, then select Revenue Budget and 2025 from the Year menu. Locate the amount for each fund sub-total in the Final Budget column. Note: The total per fund of each revenue budget should equal the tax revenue and other sources on the Certificate of Estimated Resources provided by the County Budget Commission.

8. Total Amount Available plus Balances

Calculation: Columns 6 + 7 = Column 8

Carryover Balance Available for Appropriations (column #6) plus Total Amount from all Sources Available for Expenditures (column #7)

APPENDIX 7: GAAP / FASB / OCBOA AFR FILING SUBMISSIONS

First read the 'Submission Type' instructions in section '4B - AFR Demographics & Debt' starting on page 9. Skip this appendix if you are filing AFR Regulatory.

All non-regulatory filing types must be submitted online through the Hinkle System via the entity's AOS eServices login account within the deadline set by the Auditor of State's Office.

Optional Web-GAAP Export: Non-regulatory filers can choose to use the Web-GAAP Export File option – now available in the UAN application – to create a file that can be uploaded to Web-GAAP to produce annual financial report information. That information can then be used to enter and submit online to the Hinkle System. To enable the export function, you will need to use tools in the AFR-Fund Utility to verify or edit certain information.

AFR - FUND UTILITY


You should not complete these steps until you have posted the final December 31st bank reconciliation for the fiscal year, to ensure the transactions totals in the form are final.

UAN Menu: General \rightarrow Reports & Statements \rightarrow Year End \rightarrow AFR – Fund Utility

All funds – whether active or inactive – will be on the list. **Checkmark** the funds you would like to edit and click **Edit**.




Click Web-GAAP and read the message:



Click OK and the 'Edit AFR – Fund Utility' form will open. When editing multiple funds at the same time, use the navigation arrows in the bottom left corner of the form.

The Web-GAAP fund utility includes 2 tabs: Web-GAAP Revenues and Web-GAAP Expenditures. As seen in the following images:



Review the default **code** settings in each (columns highlighted above) and select changes when necessary. Local Government Services has provided the default selections for the codes.

UAN **cannot** suggest which codes you should confirm or change in this utility. If you need guidance about the Web-GAAP utility choices, please contact Local Government Services at ContactLGS@ohioauditor.gov or 800-345-2519.


IMPORTANT

Even if you will not be changing any of the default settings, you must Save the form for every fund in the AFR-Fund Utility list or you will not be able to export the Web-GAAP file.


AFR – WEB-GAAP EXPORT

After you have saved your Web-GAAP code choices for each fund in the AFR-Fund Utility list, you will be able to export a file from UAN.

UAN Menu: General \rightarrow Reports & Statements \rightarrow Year End \rightarrow **AFR** – **Web-GAAP Export** and the following form will open:



Click Save and a confirmation message displays, as seen in the example:



The file name will include 'Web-GAAP Export' followed by your entity name, county, and the fiscal year. It will save to the C:_UAN_Efiles folder and is ready to upload to Web-GAAP.

APPENDIX 8: RECREATE AFR – AOS BACKUP IF NEEDED

Follow these steps if for any reason you need to re-create the 2024 AFR-AOS Backup (Year End Backup 3 of 3) after the fiscal year has closed or for any previous fiscal year that the entity submitted the AFR through UAN. For example, you might need to do this if you close the year successfully – which occurs after the Year End (Backup 1 of 3) completes, but accidentally cancel the AFR-AOS (Backup 3 of 3) before it completes successfully.

IMPORTANT: Resubmitting your AFR – AOS Backup will update your annual financial report filing date with the Hinkle System. This resubmission date must still fall within the legal deadline for submitting your AFR for the year - <u>financial penalties may be assessed for late filings</u>. Each local government is required to submit its Annual Financial Report to the Auditor of State within **sixty (60) days of the end of the fiscal year**. Meeting this requirement for UAN members occurs when UAN receives the 2024 AFR – AOS backup internet (or disc) submission containing the end-of-year filing data of the government.

UAN Menu: General \rightarrow Maintenance \rightarrow Year End \rightarrow AFR – Re-Create AOS Backup. Read the message carefully and click OK.

You must choose a backup destination, either Internet Submission (instructions start on page 116) or Postal Submission (instructions start on page 118). UAN recommends internet submission for entities that have access to a good high-speed internet connection.

INTERNET SUBMISSION (RE-CREATE AFR-AOS BACKUP)

Make sure the computer has an internet connection and follow the '*UAN Menu*:' on page 115 after reading the important information on that page. When the **AFR-Re-create AOS Backup** form opens:

Select '• Internet Submission – Active Connection Required.'
Click Start

An **AFR-Re-create AOS Backup <u>Options</u>** form with open; it will list all the years that your entity closed the fiscal year using UAN. Read the form carefully.

- Do not change the default Purpose:
 Re-submitting years selected below to Hinkle System'.
- \triangleright Checkmark \square the year(s) that you will resubmit.
- ➤ Checkmark ☑ the acknowledgment statement when you are ready to certify the accuracy and completeness of the AFR submission and the entity's responsibilities. '☑ I affirm ...'
- ➤ Click **Save**. The options form will close and the backup form will begin the process. After it prepares the backup for upload, a file-submission progress message will open as follows:




UAN will automatically upload the file to the AOS Hinkle System i.e. there is no need to login to a website or search for a file for upload. Please be patient. The amount of time it will take to upload the file can vary significantly depending on your internet speed and the size of the file. Entities with high-speed internet service can expect uploading the file to take 1-5 minutes for a file under 50MB, 5-10 minutes for 50-100MB files, or 10-30 minutes for files over 100MB. For entities that use the very slow 'dial-up' internet (i.e. not a high-speed internet service), UAN recommends mailing the file on a disc (see page 118 if needed).

Please note: When you browse websites, you are "downloading" information, but when you transmit a file off the computer to AOS, you are "uploading" information. Internet upload speeds

are typically 1/10th as fast as download speeds, so even though you may have a "high-speed internet" service that does not necessarily mean you have "high-speed uploads" as well.

When the upload is complete, the following message will open:



Carefully read the message and click OK.

Note: If the backup fails to upload, a status message will appear in the backup form "Backup Failed. Please try again or contact UAN for assistance." Confirm or establish an internet connection and click Start to try again. If the upload continues to fail, you can either change the type to 'Postal Submission' to create a disc for mailing or close the form and try again after establishing a good internet connection.

Be sure to read "Meeting Annual Reporting Requirements for the Auditor of State" starting on page 36 concerning the deadline requirements and steps to confirm the status of your submission.

POSTAL SUBMISSION (AFR RE-CREATE AOS BACKUP)

If the UAN computer is a laptop, connect the external CD/DVD drive and insert a blank disc in the CD/DVD tray. The computer *may* automatically open a File Explorer window – please close the window. Alternatively, the computer *might* prompt you with a message to choose what to do with the disc drive – similar to the message below.



If there is an option to cancel, then select it. Otherwise, you may choose either 'take no action' or 'open the folder to view files' and then close the folder immediately.

Follow the '*UAN Menu*:' on page 115 after reading the important information on that page. When the **AFR-Re-create AOS Backup** form opens:


Select 'O Postal Submission – CD or DVD'.


